

# ASIAN AMERICAN QUALITY OF LIFE ADVISORY COMMISSION REGULAR MEETING MINUTES OF TUESDAY, SEPTEMBER 18, 2018

The AAQOLAC convened in a regular meeting on Tuesday, September 18, 2018 at City Hall in Austin, Texas.

- **2. APPROVAL OF MINUTES:** The approval of the minutes from the Asian American Quality of Life Advisory Commission (AAQOLAC) meeting on August 21, 2018 was moved with edits by Commissioner Chen and seconded by Commissioner Saxena. The motion was approved 8-0 with Commissioners DasGupta and Patil abstaining.
