#### ORDINANCE NO.

AN ORDINANCE AMENDING THE FISCAL YEAR 2018-2019 PARKS AND RECREATION DEPARTMENT OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE NO. 20180911-001) TO ACCEPT AND APPROPRIATE AN ESTIMATED \$250,000 FROM THE TRAIL OF LIGHTS FOUNDATION FOR CITY SERVICES, AND TO AUTHORIZE THE WAIVER OF CERTAIN FEES AND REQUIREMENTS FOR THE 2018 TRAIL OF LIGHTS IN AN AMOUNT ESTIMATED AT \$225,000.

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

**PART 1.** Council waives and reimburses certain fees and requirements for the 2018 Trail of Lights Event as follows:

**PART 2.** On March 1, 2012, Council authorized negotiation and execution of a cosponsorship agreement with the Run Tex Foundation for the 2012 Trail of Lights event. On March 21, 2013, City Council directed staff to negotiate and execute a five-year
