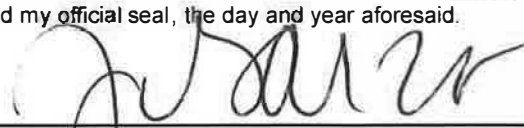

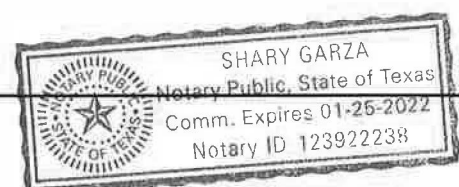

**PUBLIC HEARING NOTICE
REGARDING THE ISSUANCE OF BONDS**

Austin Housing Finance Corporation (the "Issuer") will hold a public hearing at 10:30 a.m. on September 20, 2018 at Austin City Hall, 301 W. Second Street, Austin, Texas 78701. Among the items to be discussed will be a proposal for the issuance by the Issuer of bonds (the "Bonds") the proceeds of which will be loaned to Elysium Grand, LP, a Texas limited partnership, or other affiliate of Elysium Grand, LP (the "Borrower"), to provide financing for the construction of an approximately 90-unit multi-family residential rental project to be known as Elysium Grand Apartments located near 3300 Oak Creek Drive, Austin, Travis County, Texas 78727 (the "Project") for individuals and families of low and moderate income. The maximum aggregate face amount of the Bonds is anticipated to be \$13,000,000. All interested parties are invited to submit written comments to the Issuer prior to the time set for the public hearing or to attend the public hearing and express any comments they may have regarding the Project or the Bonds.
