 - d. CHM Warnick, operations monitor contract term is to 6.30.21.
 - e. Winstead PC, general counsel to the Corporation contract has no term, but does have right to terminate with 30 day notice.
 - f. RSM, auditor for the Corporation first year was 2014.
 - g. Brown and Brown contract expires 2.14.23, but does have right to terminate with 30 day notice.
 - h. The Arbitrage Group Does bond rebate calculation. No term to agreement.
 - i. Standard and Poors contract for term of the bonds, but does have termination rights. Fees are \$55,000/year in 18-20, \$65,000 thereafter.
- 9. Receive report from John Roberts on the proposed 2019 Corporation administrative expense budget. Consider approval of such budget.
- 10. Receive report from John Roberts and Teo Gomez on the final costs compared to budget for the recently completed project to build the overhead walkway from the Hotel to Austin Convention Center ("OW").
