Authorize an amendment to an existing contract with Air Cleaning Technologies, Inc., to provide continued diesel exhaust removal systems, preventative maintenance, and inspection services, for an increase in the amount of \$400,000, for a revised total contract amount not to exceed \$750,000. (Note: Sole Source contracts are exempt from the City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program; therefore, no subcontracting goals were established).

**Additional Backup Information:**

The proposed amendment will allow the City to retrofit and upgrade the existing Plymovent diesel exhaust system at Emergency Medical Services (EMS) locations within the city. Austin Travis County EMS currently uses the Plymovent system for a portion of its fleet. The Plymovent diesel exhaust system is used to remove diesel fumes and particulates produced by EMS vehicles housed in the stations. The use of this system improves air quality, health conditions, and reduces maintenance and cleaning costs at the stations.

Air Cleaning Technologies, Inc. is the sole authorized distributor of the Plymovent system in Texas, Oklahoma, and Arkansas. No other companies are able to provide service, maintenance, or installation on these systems.
