

# AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, NOVEMBER 15, 2018

Invocation: Rabbi Alan Freedman, Temple Beth Shalom.

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, November 15, 2018 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 10:14 a.m.

- 2. take actions related to emergency communications and further expressing City Council commitment to a resilient, clean and safe water supply. "(2) COMPLAINT means a verbal or written communication alleging that an officer may have violated a civil service rule established by the City of Austin Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission, and any expansion of the definition of COMPLAINT in a labor agreement with the Austin Police Association."

To add a new PART 2. §2-15-2, (B) (10-13) to read:

- "(10) Advise the City Manager on public release of police video recordings, as soon as permitted by law, including vehicle dash camera and body worn camera video, involving incidents of significant public interest taking into consideration the City's law enforcement and public safety needs and the findings of this ordinance.
- (11) Conduct preliminary reviews of external complaints and make recommendations regarding potential department policy violations and the department's investigative review classifications;
- (12) Conduct random assessments of the department's use of force reviews and body camera usage;
  - (13) Conduct community engagement activities;"

To revise PART 2. §2-15-2, (C) to read:

- "(1) have direct access as permitted by law, to department personnel and to records of the department, including records concerning investigations, necessary to carry out the responsibilities in part (B) of this section; and
- "(2) shall make public, as permitted under Chapter 143 of the Texas Local Government Code or the terms of any labor agreement with the Austin Police Association, information received from the department."

Resolution No. 20181115-016 was approved as amended above on Council Member Casar's motion, Council Member Kitchen's second on an 11-0 vote.

74. Discuss and take appropriate action regarding the proposed Meet and Confer Agreement between the City of Austin and the Austin Police Association relating to wages, hours, and terms and conditions of employment for police officers employed by the Austin Police Department.
