a. Approval of the June 20, 2018 meeting minutes.

A motion was made to approve the minutes by Commissioner McGraw, seconded by Commissioner Schissler. Vote: 4-0 (Commissioners Greenberg and Denkler absent).

4. POTENTIAL CODE AMENDMENTS: Proposed for Discussion and/or Initiation

Potential amendments to the code are offered for discussion and/or possible recommendation for initiation. If initiated, Staff will research the proposal and report back to the subcommittee.

a. Neighborhood Plan Amendment Fee Waivers. Discuss and consider initiation of Title 25 amendments relating to fee waivers associated with Neighborhood Plan amendments initiated by Neighborhood Plan Contact Teams and Neighborhood Plan amendment fee waivers

Mark Walters described the current practice of waiving fees for neighborhood plan amendments that are initiated by neighborhood plan contact teams, as well as SMART housing projects that require a neighborhood plan amendment. The waiving of these fees is done in practice today, but hasn't been codified.

Commissioners had the following questions; staff will provide answers when the item is posted to the full PC agenda for initiation:

- Where does the money come from that makes up for waived fees?
- Can contact teams apply for property-specific changes at any time, and are they limited to the number allowed per year?

A motion was made to send the item to full Planning Commission for initiation <u>with no recommendation</u>, by Commissioner Kazi, seconded by Commissioner Seeger. Vote: 4-0 (Commissioners Greenberg and Denkler absent).

b. Definition of Mirrored Glass. Discuss and consider initiation of Title 25 amendments to update the definition of "mirrored glass" contained in 25-1-21(67). City Staff: Mark Walters, Planning and Zoning Department, (512) 974-7695, mark.walters@austintexas.gov; (Discussion and/or Possible Action).

Mark Walters explained that the current code has a definition for mirrored glass that is outdated and no longer makes sense for modern buildings. The need for a code change was precipitated by a building downtown that currently has glass with a reflectivity above 20%, which is what the current code allows. However, advances in materials and best practices means that 20% may no longer be an appropriate threshold.

Commissioners had the following questions; staff will provide answers when the item is posted to the full PC agenda for initiation:

- How will the proposed change interact/impact the pedestrian-level reflectivity described in SubChapter E?
- Where else in the code is mirrored glass referenced?

A motion was made to send the item to full Planning Commission for initiation by Commissioner Seeger, seconded by Commissioner Kazi. Vote: 4-0 (Commissioners Greenberg and Denkler absent).
