**PROPOSAL**

---

Replace rear screened porch with an addition and new screened porch; construct one-story addition to the side of the house; replace stone front walk with a concrete walk; replace driveway.

**PROJECT SPECIFICATIONS**

---

The applicant proposes to construct a 713-square foot one-story addition and a 218-square foot screened porch to the rear of the house in the place of the existing almost-full-width rear screened porch. The proposed addition will have cement fiber siding, a composition shingle roof, and a combination of sash and casement windows.

The applicant further proposes to repair and paint restore deteriorating wood elements on the house, provide a new steel handrail at the front door, install a new concrete front walk and steps, and a new driveway. The detached garage will be modified with the addition of a new door facing the back of the house.

**STANDARDS FOR REVIEW**

---

The Old West Austin National Register Historic District has no design guidelines regarding the construction of additions to contributing properties. The Commission applies the Secretary of the Interior's Standards for Rehabilitation to evaluate these projects:

2. The historic character of a property shall be retained and preserved. The removal of historic materials and alteration of features and spaces that characterize a property shall be avoided.
6. Deteriorated historic features shall be repaired rather than replaced. Where the severity of deterioration requires replacement of a distinctive feature, the new feature shall match the old in design, color, texture, and other visual qualities and, where possible, materials. Replacement of missing features shall be substantiated by documentary, physical, or pictorial evidence.
9. New additions, exterior alterations, or related new construction shall not destroy historic materials that characterize the property. The new work shall be differentiated from the old and shall be compatible with the massing, size, scale, and architectural features to protect this historic integrity of the property and its environment.
10. New additions and adjacent or related new construction shall be undertaken in such a manner that if removed in the future, the essential form and integrity of the historic property and its environment would be unimpaired.

In addition, The Secretary of the Interior's Technical Preservation Services Bulletin "Planning Successful Rehabilitation Projects" states:

New construction needs to be built in a manner that protects the integrity of the historic building and the property's setting. Related new construction, including buildings, driveways, parking lots, landscape improvements and other new features, must not alter the historic character of a property.

New construction should be placed away from or at the side or rear of historic buildings and must avoid obscuring, damaging, or destroying character-defining features of these buildings or the site.

The massing, size, scale, and architectural features of new construction on the site of a historic building must be compatible with those of the historic building. When visible and in close proximity to historic buildings, new construction must be subordinate. New construction should also be distinct from the old and must not attempt to replicate historic buildings elsewhere on site and to avoid creating a false sense of historic development.

The proposed new additions comply with the applicable design standards. They are located on the rear and side of the house; the proposed front walk and driveway do not detract from the historic character of the property.

**STAFF COMMENTS**

---

The existing house is contributing to the Old West Austin National Register Historic District. It was constructed in 1935, and was the home of insurance man Wofford R. Rathbone and his wife Helen from around 1935 until around 1943; then the home of B. Carroll and Martha McPherson from around 1946 until very recently. B. Carroll McPherson was the local representative of the L.G. Balfour Company, manufacturers of class rings. The existing screened porch across the back of the house was added by the McPherson family in 1948.

**STAFF RECOMMENDATION**

---

Release as proposed with the recommendation that the applicant consider wood as a material for the proposed new front handrail, and upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, to record existing conditions, for archiving at the Austin History Center.

#### **BIOGRAPHICAL NOTES:**

##### **Wofford R. and Helen Rathbone (ca. 1935 – ca. 1942)**

Wofford and Helen Rathbone appear in the 1930 U.S. Census for New Orleans, Louisiana, where they rented a house. Wofford Rathbone was 38, had been born in Texas, and was a salesman for a wholesale oil company. Helen Rathbone was 30, had been born in Louisiana, and had no occupation listed. They had 2 daughters: Helen, 9; and Beryl, 8, both of whom had been born in Louisiana. With them lived Helen Rathbone's mother, Helen Dufour, a 49-year old Louisiana-born widow with no occupation listed. The family had a live-in African-American servant, Rose, Delmose, 25, who had been born in Louisiana. In 1920, according to the census report of that year, Wofford and Helen Rathbone were living in New Orleans where he was a salesman for a ship chandler.

The 1940 U.S. Census shows Wofford R. and Helen D. Rathbone as the owners of this house, which was worth \$10,000. Wofford R. Rathbone was 48, had been born in Texas, and was a life insurance agent. Helen D. Rathbone was 40, had been born in Louisiana, and had no occupation listed. They had 2 daughters: Helen, 20; and Beryl, 18. Both girls were born in Louisiana, and neither had an occupation listed.

According to his 1942 World War II draft registration card, Wofford Robert Rathbone was living in this house. He was born in 1892 in Cuero, Texas, and was employed by the Union Central Life Insurance Company of San Antonio, Texas. His next of kin was Mrs. Helen Dufour Rathbone, his wife.

Both Wofford and Helen Rathbone are buried in Cuero, Texas.

*Dufour was born on September 24, 1899 to William Cyprien Dufour of New Orleans and Helen McLeary Dufour of San Antonio. When she returned to New Orleans in 1918 she met and married Lieutenant Wofford Robert "Sonny" Rathbone, of Cuero, Texas, then stationed at Jackson Barracks with the United States Coast Artillery and later at Fortress Monroe. The young couple remained in Louisiana for several years prior to moving to Austin, Texas in 1933. During World War II they lived for a time in San Antonio, where Captain Rathbone served at the San Antonio Arsenal. Mr. Rathbone preceded his wife in death in 1968, a few months after celebrating their 50th wedding anniversary. Mrs. Rathbone moved to Atlanta in 1989, where she celebrated her 100th birthday on September 24th, 1999 surrounded by numerous relatives and friends. She moved back to Texas in 2001 to the Glaspy Ranch near Ennis, where she lived with her granddaughter and grandson-in-law, Mr. and Mrs. William M. Glaspy. In addition to her husband, Mrs. Rathbone was preceded in death by her brother, Elmore Dufour of San Antonio. She is also survived by two nephews, James Crain of Cuero, Texas and Generes Dufour of Austin. **Helen Dufour Rathbone**

Helen Dufour Rathbone died at the age of 105 on March 6, 2005, at the IOOF Nursing Home in Ennis, Texas. A native of New Orleans, Helen Dufour was born on September 24, 1899, to William Cyprien Dufour of New Orleans and Helen McLeary Dufour of San Antonio. Among her paternal grandparents were Cyprien and Louise Donnet Dufour of New Orleans, and Elmore and Blanche de Generes Dufour. Her maternal ancestors included the Eppes and Hardeman families of Colonial Virginia, the Hon. Seth Lewis of Mississippi and Louisiana, Dr. Valentine Overton King, his wife Helen Lewis King, originally of Opelousas, and James Harvey McLeary, Attorney General of Texas in the early 1880s, appointed Associate Justice of the Montana Supreme Court and later Associate Justice of the Supreme Court of Puerto Rico.

As a young girl, Helen attended Notre Dame Convent in Baltimore, Maryland. When she returned to New Orleans in 1918 she met and later married Lieutenant Wofford Robert "Sonny" Rathbone of Cuero, Texas. He was stationed at Jackson Barracks with the United States Coast Artillery and later at Fortress Monroe. At the end of WWI Sonny resigned his commission and he and Helen remained in New Orleans where their two daughters, Helen and Beryl (Babs) were born. While Sonny worked, Helen was busy with the two girls and their activities and her work as a Junior League volunteer.

The Rathbone family moved to Austin in 1933 where they lived in a house on Red River Street, which is now the site of St. David's Hospital. Helen found herself involved in her new community. She enjoyed playing Bridge and Canasta, became active in the Junior League, and became a member of St. Austin's Catholic Church. During World War II, for a period of four years, Sonny and Helen lived in San Antonio where Captain Rathbone served at the San Antonio Arsenal. On their return to Austin Helen resumed her activities. She frequently attended Saturday afternoon mass at the Convent of Divine Adoration when it was still located in Austin and often volunteered to transport the "Sisters" to various doctor and dentist appointments. One of her greatest joys came from visiting the residents in one of the local nursing homes.

Mr. Rathbone preceded his wife in death in 1968, just a few months after the celebration of their 50th wedding anniversary. Mrs. Rathbone moved to Atlanta, Ga. in 1989 where she celebrated her 100th birthday on September 24th, 1999, surrounded by numerous relatives and friends. The summer of 2001 she moved to the Glaspy Ranch near Ennis, Texas, where she lived with her granddaughter and grandson-in-law, Mr. and Mrs. William M. Glaspy.

In addition to her husband, Mrs. Rathbone was preceded in death by her brother, Elmore Dufour of San Antonio. She is survived by her two daughters, Helen Rathbone de Galian of Atlanta, Georgia, and Beryl Rathbone Lawson of Austin, Texas. She is also survived by two nephews, James Crain of Cuero, Texas, and Generes Dufour of Austin. In addition, she leaves behind 19 grandchildren, 51 great-grandchildren, and seven great-great-grandchildren who fondly called her "Mutsie."

Reverend Benjamin Carroll McPherson, 101, died peacefully on April 28, 2011 in his Austin home where he had resided since 1942. His loving wife, Martha Bundy McPherson, and their children and grandchildren were with him at the end.

Carroll McPherson was born into a clan of McPhersons and Bells near Hallsville, Texas on September 26, 1909. After completing high school in Hallsville, he attended Lon Morris Junior College, Southern Methodist University and graduated from the University of Texas at Austin in 1948.

In his early 20s, Carroll moved to Austin to work for the L.G. Balfour Company. He soon met and married Martha Bundy, a beautiful red-head from West Texas. They were married at Martha's home on the Bundy Ranch near Junction, Texas in December 1936. Their devotion to one another lasted for more than 75 years and has been an inspiration to all who knew them. Carroll McPherson was a Christian gentleman who was known for his appreciation of a good story, a wry wit, an amazing memory and his strong Texas and Scottish roots.

During his long career with Balfour, he began studies at the Episcopal Seminary of the Southwest. Upon completion of his studies at the Seminary, he was ordained an Episcopal priest in 1969. Carroll and Martha were first assigned to Beaumont and Bridge City, Texas. After two years they returned to Austin and Carroll became an assistant at the Church of the Good Shepherd. Over the years, he and Martha enjoyed interim assignments in Amarillo, Midland, Abilene and San Miguel de Allende, Mexico. He retired from active ministry in 1992 at age 83.

Carroll was a member of Lamda Chi Alpha fraternity and he enjoyed his membership in the Bachelors Club of Austin. He was a 32nd Degree Scottish Rite Mason and a member of the Ben Hur Shriners. He was a founder of the North Austin Rotary Club.

Reverend McPherson is survived by his wife Martha, his son Benjamin McPherson and wife Marie, his daughter Mary Polk and husband James, his five granddaughters, Jennifer McPherson, Sarah McPherson Bowland, Alice McPherson Pierce, Molly Harding Polk and Annie McPherson Polk. He is blessed with eight great grandchildren. He was preceded in death by his mother Kitty Bell McPherson, father Malcolm Alison McPherson and brother DeWitt McPherson.

No one appreciated more than Carroll the value of good friends and there are many. After more than seven decades in the same home, Carroll and Martha's neighbors, both past and present, are part of their family. The friendship of Hermelinda Sarrejano cannot be measured.

The funeral service is on Monday, May 2, 2011 at 11:00 a.m. at the Episcopal Church of the Good Shepherd, 3201 Windsor Road in Austin. Interment will follow at Austin Memorial Park.
