PROPOSAL

Demolish a ca. 1939 house.

ARCHITECTURE

One-story, L-plan, stuccoed frame house with single 6:6 fenestration and minimal Colonial Revival stylistic elements.

RESEARCH

The house was built in 1939 by Theresa Winn, the widowed daughter of A.W. and Annie Johns, several months after her father passed away. A.W. and Annie Johns lived in a large, 2-story house just up the hill from this house at 701 Theresa Avenue. A.W. Johns was a prominent building contractor; he passed away in March, 1939, about 6 months before his daughter Theresa (for whom, it is believed, Theresa Avenue is named) took out a building and utility permits to construct this house for herself and her widowed mother. Annie Johns lived here for the rest of her life; she passed away in 1945. Theresa Winn, who worked for years at Roberdeau Van and Storage Company, lived here until her death in 1958.

Following the ownership and tenancy of Theresa Winn and her mother, the house was purchased by Douglas and Janet Packard, who were living here in the 1990s. Douglas Packard was the plant manager for Austin White Lime Company, located northwest of Austin at McNeil, Texas.

STAFF COMMENTS

The house was listed as non-contributing to the West Line National Register Historic District. Staff does not agree with this determination as the house retains a high degree of integrity.


Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. Architecture. The house is a stuccoed frame house with minimal references to the Colonial Revival style with its symmetrical composition and use of single 6:6 windows. However, the Colonial Revival was a very popular style in Austin and this house is not a particularly good example of it; Colonial Revival houses rarely used stucco as an exterior cladding material. There does not appear to be sufficient architectural distinction to warrant the designation of this house as a historic landmark under the architectural criterion.
- b. **Historical association**. The house was built by the daughter of a prominent contractor after he passed away as a home for herself and her widowed mother. The daughter, Theresa Winn, was a clerk and stenographer for a local moving and storage company. There do not appear to be significant historical associations.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.

e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.. The house does not meet the criteria for individual designation as a historic landmark. However, staff disputes the call that this house is non-contributing to the historic district in that it retains a high degree of integrity, so staff will not release the permit until the Commission has reviewed the plans for the replacement structure.

BIOGRAPHICAL NOTES:

Annie Johns / Theresa Winn (ca. 1939 – ca. 1958)

The 1940 U.S. Census shows Annie M. Johns as the owner of this house, which was worth \$4,000. Annie M. Johns was a 77-year old Alabama-born widow with no occupation listed. With her lived her daughter, Theresa Winn, 40, a Texas-born widow who worked as a stenographer for a storage garage.

The 1930 U.S. Census shows Alex W. and Annie Johns as the owners of the house at 701 Theresa Avenue, which was worth \$12,000. Alex W. Johns was 75, had been born in Georgia, and was a building contractor. Annie Johns was 69, had been born in Alabama, and had no occupation listed.

Annie Johns' husband, Alexander Whitfield Johns, was living at 701 Theresa Avenue at the time of his death in March, 1939. He was born in 1855 in Georgia, and was a building contractor.

Annie Nisbet Johns was living in this house at the time of her death in September, 1945. She was a widow who had been born in Jacksonville, Alabama in 1861, and kept house.

According to her death certificate, Theresa Johns Winn was living in this house at the time of her death in 1958. She was born in Burnet, Texas in 1898, and was employed by the Roberdeau Van and Storage Company. She was a widow.

MRS. ANNIE JOHNS

Mrs. Annie Nisbet Johns, 84, widow of the former building contractor, A, W, Johns, died at her home, 609 Theresa, Thursday, Mrs. Johns had been a resident of Austin since 1909 and was a member of the University Presbyterian church. She is survived by one daughter, Mrs. T. J. Winn of Austin; three sons, F. M. Johns of Houston, A. W, Johns, Jr., of Glendale, Calif., and M. S. Johns of Austin.

Funeral services will be conducted by the Rev. Harry M. Moffett at the Weed-Corley Funeral home at 10 a. m. Friday. Burial will be in Oakwood cemetery.

MRS. THERESA JOHNS WINN

Mrs. Theresa Johns Winn, 609 Theresa, died suddenly at her home early Wednesday. She had been a resident of Austin since 1909 and was a graduate of Austin public schools and the University of Texas. For many years she has been associated with the Roberdeau Van and Storage Company. Mrs. Winn was a member of University Presbyterian Church.

Survivors are three brothers, Floyd M. Johns, and N. S. Johns, both of Austin and A. W. Johns Jr. of Pasadena, Calif.

The body is at Weed-Corley Funeral Home pending definite funeral arrangements.


