Dear Commissioners:

I am writing to oppose the demolition at 508 Mary Street, a property contributing to the Mary Street Local Historic District.

It is very disheartening that neighbors should even have to write these letters, given that the ordinance should be effective enough that we no longer are required to fight these demolition cases house-by-house, and once again, at the 11th hour. And yet, somehow this homeowner insists on bringing the case here before you, presumably unaware of the ordinance, with some idea that the demolition can be accomplished. We neighborhood supporters, and certainly the residents of Mary Street, were told that a Local Historic District is the most effective way to preserve our quickly disappearing historic structures, and we look to you and our various City leadership to enforce this ordinance that the residents of this street voted for.

As you are aware, this neighborhood has fought long and hard for a Local Historic District as we seek tools to preserve our historic fabric, even (and especially) for our most threatened modest historic homes that maintain Travis Heights' original character. Mary Street is one of the few streets in Travis Heights that is almost entirely intact, except for one structure lost only months before the LHD was passed. Losing this house will jeopardize the integrity of this single-street district that neighbors worked so hard to protect.

I hope the homeowner can instead achieve their vision by adding on to the property using the district's design standards, as well as the tax incentives available to them should they choose to restore and renovate the house.

I live on Mary Street two houses away from this property, and worked hard with my neighbors to achieve LHD protections. I am surprised to even see this case coming up, because the law is very clear. This property is part of the LHD and must be protected.

I only heard that this case was coming up again a few days ago, and I cannot be there in person to fight it. We were not re-noticed about the new date. Please don't take my absence as not caring about this demo. WE DO NOT WANT TO LOSE OUR HISTORIC HOUSES! It's really unfair, and possibly even purposely deceitful, for the owner to first drop her case, and then ask to be added back to the agenda TWO MONTHS LATER without re-noticing the neighbors, right before the holidays.

Please do not be swayed by some sob story from the owner about how she didn't know about the LHD, or about the state of the house. It CAN be renovated and added on to, or she can sell this house and buy another one to demolish. She only recently purchased it and has never lived in it. There is no reason to make an exception in this case.
