Commissioner King moved approval of the June 13, 2018 regular Small Area Plan Joint Committee meeting minutes with a second by Commissioner Duncan, on a vote 4-0, with Commissioners Thompson and Kiolbassa not in attendance.

4. NEW BUSINESS

a. 70 Rainey Street/Rainy Street Residential: Variance to the Waterfront Overlay Combining District — The applicant is seeking a variance to the Waterfront Overlay Combining District section 25-2-721(E)(1) regulations pertaining to the prohibition of mirrored glass or glare producing glass surface building materials..

Commissioner Anderson made a motion to recommend the variance to 25-2-721(E)(1), initiate a code amendment to reexamine the mirrored glass definition in 25-1-21(67) with consideration given to energy efficiency, best practices, and existing conditions in Austin, and report back to the Committee with a second by Commissioner Duncan on a vote 4-0, with Commissioners Thompson and Kiolbassa not in attendance.

b. Community Concerns Regarding the East Riverside Corridor Plan Regulating Plan — The Committee will discuss community concerns regarding the East Riverside Corridor Plan Regulating Plan. (Discussion and/or Possible Action)

Commissioner King moved to postpone the agenda item to the October Small Area Planning Joint Committee with instructions to staff to prepare a presentation on development and demographic changes in the East Riverside Corridor with a second by Commissioner Duncan, on a vote 4-0, with Commissioners Thompson and Kiolbassa not in attendance.

c. Ex Officio Members for the Small Area Planning Joint Committee — Staff will provide an overview of the process and the status of expanding membership of the Small Area Planning Joint Committee through the addition of ex officio members who possess special knowledge of the issues affecting the area covered by the Waterfront Overlay Combining District. (Discussion and/or Possible Action)

Commissioner King moved to, 1.) Send a recommendation to the City Council to consider expanding the Small Area Planning Committee's membership through the addition of two ex officio members with experience in Waterfront Overlay issues, and 2.) Request that the Planning Commission initiate a code amendment to expand the membership of the Small Area Planning Joint Committee with a second by Commissioner Duncan. The vote failed 3-1 with Commissioner Anderson voting against the motion with Commissioners Thompson and Kiolbassa not in attendance.
