2. APPROVAL OF MINUTES AND ACTION

a. Board Member Linda Guerrero made a motion to approve the draft November 19, 2018 minutes, seconded by *Vice-Chair* James Schissler. Board Member Samuel Franco proposed changing every mention of the SCW TIF Study to SCW Market Study in Item 3.a. to accurately reflect the update provided to the Board. The motion to approve with changes proposed by Board Member Samuel Franco passed with 5 yes, 1 abstain, and 3 absent votes.

3. ITEMS FOR DISCUSSION AND POSSIBLE ACTION

- a. Potential Collaboration Approaches with City Departments The Board discussed presentations by the Finance Services Department and the Economic Development Department during the November 2018 SCWAB meeting and expressed dissatisfaction with the current working relationship of the Board with these departments. Chair Bailey requested the Finance Working Group to organize meetings with these departments to establish and build a collaborative working relationship as the Tax Increment Finance District and the Local Government Corporation is set up for the SCW District.
- b. 2019 SCWAB Meeting Schedule Staff Liaison Sravya Garladenne informed the Board of the meeting room locations for the 2019 SCWAB meetings. The Board discussed this but no action was taken.
- c. DRAFT SCW Regulating Plan Staff Liaison Sravya Garladenne provided an update on the Draft SCW Regulating Plan. The Board discussed this and requested the Staff to work with Board Member Pilar Sanchez on the Affordable Housing Section. The Board also requested updates from the Watershed Protection Department on the Environmental Regulations in the Regulating Plan. No action was taken.
