PROPOSAL

Demolish a ca. 1956 house.

ARCHITECTURE

One-story, L-plan front- and side-gabled painted brick house with a partial-width inset porch; metal-framed casement and sliding windows.

RESEARCH

The house was built in 1956 by Frank Barron, a local builder and developer. The first owners and occupants of the house were Otis A. and Gloria Singletary, who lived here until around 1961. Dr. Otis A. Singletary was a professor of history, and especially military history, at the University of Texas. He was schooled in Mississippi and Louisiana, and taught history before moving to Austin in 1954 for his position at the University of Texas. Dr. Singletary was appointed the head of the federal Job Corps by President Lyndon Johnson in 1964 and then became the chancellor of University of North Carolina at Greensboro in 1966. He later became the president of the University of Kentucky.

The house was vacant for much of the 1960s, then purchased by Norma Brooks, an examiner at the IRS in the late 1960s. Around 1970, the house was purchased by William P. and Shirley Terry, who lived here for the rest of their lives. William P. Terry was the manager of a furniture rental business who later went on to work for a moving and storage facility.

STAFF COMMENTS

The house is beyond the bounds of any City survey to date.

Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a ranch house with mid-century Modern stylistic features, particularly in the fenestration. The house does not appear to meet the criterion for architectural significance.
- b. **Historical association.** The house was first owned by Otis Singletary while he was a professor of military history at the University of Texas; although he later went on to become head of the federal Job Corps, and the leader of UNC-Greensboro then the University of Kentucky, his association with this house came at a time when he taught at UT. Later owners and occupants do not appear to have significant historical associations.
- c. **Archaeology.** The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value.** The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.

BIOGRAPHICAL NOTES:

Dr. Otis A. and Gloria Singletary (ca. 1956 – ca. 1961)

According to the online Wikipedia article on him, Otis Arnold Singletary was born in Gulfport, Mississippi in 1921, received his undergraduate degree from Millsaps College in Mississippi, and his master's and Ph.D. from Louisiana State University. He moved to Austin in 1954 to begin teaching history at the University of Texas. He rose through the ranks of the History Department to be named a full professor of history in 1960. He was the associate dean of the School of Arts and Sciences in the late 1950s, and assistant to the university president in the early 1960s, before moving on to become chancellor of the University of North Carolina at Greensboro, a position he held from 1961 to 1966, with a leave of absence from 1964 to 1966 to serve as President Lyndon Johnson's appointment to head the federal Job Corps. He became president of the University of Kentucky in 1969, and served until his retirement in 1987. He died in Lexington, Kentucky in 2003.

Book Fund Award Goes To Dr. Otis A. Singletary

WASHINGTON, D. C., May 26—A Moncado Book Fund award to Dr. Otis A. Singletary, University of Texas history instructor, was announced at an American Military Institute luncheon here Thursday.

The prize was for Dr. Singletary's unpublished manuscript, "The Negro Militia Movement During Radical Reconstruction."

Honorable mention certificates went to Dr. James L. Nichols of Nacogdoches, who has master of arts and doctor of philosophy degrees from the University of Texas, and to Colonel Robert Arthur of New Orleans, La., retired Army officer.

Dr. Singletary is a graduate of Millsaps College, Jackson, Miss., and has master of arts and doctor of philosophy degrees from Louisi-

ana State University. He served with the Navy in the Pacific during World War II, was recalled during the Korean emergency, and is now a lieutenant in the Naval Reserve.

For his study of the Negro militia, he used original sources, many of them in state archives and hitherto virtually untapped. The announcement said Dr. Singletary "has handled a controversial and little understood topic with great objectivity, originality and lucidity."

Judges, who were unanimous in their decision, praised the "thoroughness of his scholarship and the clarity and liveliness of his presentation," and expressed hope arrangements can be made for the study's publication "so that it will reach the wider audience it so richly deserves."

Singletonary Leaves University

RALEIGH, N.C. (AP)—Dr. Otis Singletonary resigned Friday as chancellor of the University of North Carolina at Greensboro.

Dr. Singletonary, 49, who came to the Greensboro campus five years ago from the University of Texas, said he had accepted a position as vice president of the American Council of Education in Washington. The change is effective Nov. 1.

Dr. William C. Friday, president of the consolidated university, called Dr. Singletonary "a most able and distinguished education administrator who has made substantial and lasting contributions to the university at Greensboro and the university as a whole."

Dr. Singletonary was named by President Johnson in 1964 as the first director of the Job Corps under the federal anti-poverty program. He returned to the campus late in 1965.

Dr. Singletonary said his new post "will give me a chance to really study and think about the problems of higher education," and a chance to write.

Dr. Singletary will succeed Dr. Allen M. Carter who has been named chancellor and executive vice president of New York University.

A native of Gulfport, Miss., Dr. Singletary attended Millsaps College in Jackson, Miss., and received his Ph.D. in military history from Louisiana State University. He served in the Navy during World War II.

At Texas, he served as assistant to the president and mixed history teaching with his administrative duties. He won three awards for excellence in teaching.

Bill is survived by wife and sweetheart of 50 years, Shirley Neal Terry; daughter, Shannon Terry-Kollars and her husband Kelly of Leander; daughter, Molly Goodson and her husband Eric of San Antonio; granddaughters, Asia and Allegra Kollars and grandson, Mason Goodson; brother, Don Terry and his wife Charlotte of Kerrville and sister, Billie Smith of West Brandywine, Penn.; numerous nieces and nephews and their families as well as many friends. He was preceded in death by his parents.

Family and friends will gather at 10:00 a.m. on Thursday, February 3, 2005, at Saint Mark's Episcopal Church in Austin, Texas, for a memorial service and reception.
