HISTORIC LANDMARK COMMISSION JANUARY 28, 2019 DEMOLITION AND RELOCATION PERMITS HDP-2018-0665 1411 HASKELL STREET

PROPOSAL

Demolish a ca. 1936 house.

ARCHITECTURE

One-story, rectangular-plan, front-gabled frame cottage with a partial-width, front-gabled independent entry porch on plain, square wood posts; single 6:6 fenestration, with modern replacement windows.

RESEARCH

The house was constructed around 1936; the first owners and occupants were Christopher J. and Beulah Pruitt who lived here until around 1954. Christopher Pruitt was a dairy farmer and livestock dealer; Beulah Pruitt worked at Yaring's. Christopher Pruitt was awarded a posthumous Carnegie medal for trying to save the life of a man who drowned after his boat capsized in the Colorado River east of Austin. Christopher Pruitt himself drowned in his rescue attempt.

From around 1954 until 2000 the house was owned and occupied by Charles C. and Martha Harper. Charles C. Harper was a house painter; after his death in 1962, Martha Harper continued to live in this house; she passed away in 2000.

STAFF COMMENTS


The house was not recommended for individual designation nor as contributing to a potential historic district in the East Austin Historic Resources Survey (2016).


Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a frame mid-1930s cottage with little architectural distinction and replacement windows. While the house retains its form and character, it falls short of the criterion for architectural merit.
- b. **Historical association**. The house was owned by a dairy farmer and his family from the time of its construction until around 1954. From around 1954 to around 2000, the house was owned by a house painter. There do not appear to be significant historical associations.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.

BIOGRAPHICAL NOTES:

Christopher J. and Beulah Pruit (ca. 1933 – ca. 1954)

His 1917 World War I draft registration card shows that Christopher John Pruitt was living at O'Donnell, Texas, where he was a self-employed farmer. He was born in 1894 in Blanco, Texas. He was married. He was tall and slender and had blue eyes and light hair.

The 1930 U.S. Census shows John C. and Beulah Pruitt renting the house at 1102 Blanco Street in Austin. John C. Pruitt was 34, had been born in Texas, and was a mechanic for the street railway company. Beulah Pruitt was 31, had been born in Texas, and was a saleslady for a retail dry goods store. They married when John C. was 19, and Beulah was 16. They had two children: Christine H., 8; and Claud V., 6. Both children had been born in Texas.

Christopher J. and Beulah Pruitt appear in the 1940 U.S. Census as the owners of this house, which was worth \$2,500. Christopher J. Pruitt was 44, had been born in Texas, and had a retail milk route. Beulah Pruitt was 42, had been born in Texas, and had no occupation listed. They had 4 children: Christine, 19, a cashier in a cafe; Claude, 16; Kenneth R., 7; and Jo Ann, 3. All the children had been born in Texas. With them lived Christopher Pruitt's brother, David F. Pruitt, a 43-year old divorcee who had been born in Texas and had no occupation listed.

His 1942 World War II draft registration card shows Christopher John Pruit living at this address. He was born in Blanco County, Texas in 1894 and was a self-employed dairyman.

Two Drown in River

Two men drowned but two boys managed to swim to safety Tuesday evening when their small motor boat overturned in the Colorado River east of the city.

The victims were Chris J. Pruitt, 70, of Route 1, and Arvin Traugott, 26, of 2326 Webberville Road.

Escaping death in the river about three miles downstream from the Montopolis bridge were. Pruitt's two grandsons, Jeff Pruitt, 6, and Gary Pruitt, 5.

The boys are the sons of Mr. and Mrs. Kenneth Pruitt.

The party's 12-foot flatbottom

boat capsized about 10 minutes after the foursome set out to check trotlines near the elder Pruitt's home on Shelton Lane.

The young boys swam the 12foot deep waters to come through the mishap unscathed. A rescue boat from the Ausfin Fire Department dragged

tin Fire Department dragged the Colorado for more than three hours before bringing up the bodies of the two men.

Pruitt's body was recovered just after 10 p.m. about 20 feet from where the boat sank. Traugott's body was found 45 minutes later in the same vicinity.

The bodies were apparently carried downstream by a swift current running in that portion

of the river.

Young Jeff said the boat was near the middle of the river when the engine was cut off too fast and the front end of the craft dipped into the water.

As the front end filled with water, the four persons aboard got to the back of the boat. The boat then heaved backward and the engine went underwater.

"We all tried to get in the middle of the boat," Jeff said.
"But it was filling up with water so we all jumped. Everybody went in a different direction."

Jeff said he was swimming toward the bank and only at one point did he see his brother and grandfather in front of him.

"I saw Gary almost at the bank and I just saw about that much of granddaddy's head," Jeff recalled. "Then I got into a whirlpool and I thought I couldn't get out.

"When I finally did, I saw
Gary already on the bank, but
I didn't see granddaddy again."
Jeff said he never saw Traugott swim away from the boat.

Gary told his folks that his grandfather gave him a push toward the bank when they first abandoned the boat.

Indicated by the spot where Pruitt's body was found, the elderly man must have swum with Gary about half the distance to the bank.

"Gary was the only member of the foursome wearing a life jacket. Like Jeff, he came out on the opposite bank from where their boat had been launched.

The bank at the point where
the boys came out is very steep,
going almost straight up five or
more feet. The steep shoreline
is covered with heavy brush.
As soon as the boys got out

As soon as the boys got out of the water they ran to their grandmother's house for help.

Jeff showed rescue workers where the boat went down by pointing out a gas can that had been on board. The boat was found a few feet from the spot.

Justice of the Peace Jerry Dellana was called to the scene by the Travis County sheriff's office. Judge Dellana said he probably would rule on the deaths Wednesday.

Scuba divers were standing by, but the darkness and the muddiness of the water kept them from going into the river.

Traugott's body was taken to Hyltin - Manor Funeral Home where arrangements are pending. Traugott, a carpenter, was a member of the Baptist church and a lifelong resident of Austin.

Traugott is survived by his widow, Trina; son, Arvin Traugott Jr., who was Austin's New Year's Baby this year; daughter, Alivia Traugott; parents, Mr. and Mrs. Frank Traugott, Austin; three brothers; Travis Traugott, Frank Traugott, and Ernes Traugott, Austin; sister, Miss Mary Rose Traugott, Austin; and two half sisters.

Funeral for Pruitt is pending at Wilke-Clay Funeral Home. Pruitt had only recently retired as an independent building contractor. He was a member of South Austin Christian Church. He is survived by his widow, Buleah Edith; two daughters, Mrs. James Weiler, Houston, and Mrs. Charles Koehn, Milwaukee, Wis.; two sons, Lt. Col. Victor C. Pruitt, US Air Force, Germany, and Kenneth R. Pruitt, Austin, who is the father of the two boys; three sisters, Mrs. Rebecca Hicks, Mrs. Nancy Steddum, and Mrs. Clarice Seller, San Antonio; and Mix grandchildren.

The 1940 U.S. Census shows Charles C. and Martha Harper living in a rented house in Justice Precinct 3 of Travis County. Charles C. Harper was 30, had been born in Texas, and was a foreman for a WPA street construction project. Martha Harper was 25, had been born in Texas, and had no occupation listed. They had 3 children: Betty, 5; Robert, 3; and Charles C., Jr., 5 months. All the children had been born in Texas. The family lived in rural Colorado County, Texas in 1935. The family also had a lodger, Bonna F. Dickerson, a 55-year old Texas-born widower who worked as a foreman for a WPA brush-cutting program.

The 1930 U.S. Census shows Charles Harper as the 20-year old son of Pearl Harper, a 37-year old widow who rented her home in rural Navarro County, Texas. Charles Harper was born in Texas and was a farm laborer. He was the oldest of Pearl Harper's three sons listed in the census report.

Charles C. Harper died at the UTMB hospital in Galveston in 1962. He was born in Brownwood, Texas in 1910 and was a painter. He was living at this address at the time of his death.


