Efforts Help Low Income Customers Reduce Energy Use

- •94,000 customer dwellings weatherized or AE Green Building rated
 - 18,800 single family homes
 - 68,000 apartment units
 - Over 7,200 S.M.A.R.T. housing units
- Enhanced solar incentives
 - For affordable housing and non-profits
 - 400 low income customers added to community solar and shared solar in last year
- Direct installation of lighting, outreach, point of sale discounts, school kits and other City department collaboration complement efforts



How Did We Reach Low Income Customers in FY18?



809 low income homes weatherized



 Over 1,500 affordable apartments weatherized with 30,000 LEDS and 4,600 water savings devices



15,000 homes received efficiency lighting



CAP Single Family Weatherization - example Insulation, weather stripping and sealing, duct repair, solar screens, lighting



Multifamily Program

Measures: duct seal, insulation, solar screens, lighting

Future:

- Consolidating eligibility sources (Texas Energy Poverty Research Institute and the Housing Authority of the City of Austin)
- RFPs for property owner/manager outreach and best practices contractor recruitment, tenant education, quality assurance, success metrics






Low Income Weatherization






Low Income Multifamily Weatherization







Solar Incentives for Affordable Housing

- Non-profits, including affordable housing providers, are eligible for Commercial Solar Performance Based Incentives (PBIs)
 - Non-profits are eligible for higher incentives, and exempted from customer cap
- Affordable Housing eligible for enhanced residential rebates if individually metered
 - -Currently \$0.60/W installed, up to \$2,500 per unit
- FY18 participants included:
 - -Foundation Communities
 - -Guadalupe Neighborhood Development Corporation

Shared Solar Pilot for Multifamily Affordable Housing

- Feb 2018 Call for Participants; 3 pilot projects installed fall 2018
- Pilot Incentive: \$1/Watt with \$0.80/Watt adder for net-zero energy capable
- Value of Solar (VOS) credits issued on bills started November 2018
- Automated billing expected to go live in Spring of 2019

Community Solar

- Allows renters and others to access local solar without installing on their own roof
 - No upfront cost, no contract, no maintenance, moves with customer
- Community Solar Projects
 - 185 kW Palmer Events Center rooftop solar (2016)
 - 2.6 MW La Loma solar farm (2018)
- La Loma Community Solar Low-Income Discount
 - Half of La Loma's capacity is reserved for CAP customers
 - 220 CAP participants receive 1.5¢/kWh discount on Community Solar rate, makes the program less expensive than regular power from day one

Low Income Solar Incentives through January 2019

Over 3,000 low-income customers have benefitted from AE's solar incentives directly or indirectly, vs. 7,300 single-family residential rooftop solar customers.

Summary

- Industry leading weatherization programs have improved 94,000 customer residences
 - 18,800 homes weatherized since 1980
 - 68,000 apartment units (low and moderate income) weatherized since 1991
 - 7,200 Austin Energy Green Building S.M.A.R.T. housing units
 - Many program and utility partners
- Supplement program with direct installation, retail discounts, school based education, outreach events
- ~30% of residential solar customers are low income
 - 2,837 affordable housing residents
 - 220 low income discount community solar customers
 - Shared solar pilot for 3 low income multifamily affordable housing properties (177 customers)
