PROPOSAL

Rehabilitate a ca. 1910 house, expand the footprint at the front and rear, and construct a rear two-story addition with a roof deck.

ARCHITECTURE

Cross-gabled, T-plan house clad in wood, with 2:2 and 1:1 double-hung wood-sash windows and a half-width porch.

RESEARCH

The house was constructed around 1910. Two families have occupied it for sustained periods of time: James and Wilhelmina Turpen (ca. 1918-35) and Edward and Sadie Harris (ca. 1940-59). James Turpen worked for two decades as a captain at the fire station just down the block, while Edward Harris worked as a tile layer. After the Harrises moved out, the house was occupied by a succession of renters.

The house appears to remain in its original form, and no major changes are noted in building permits for the property. Renters were listed alongside owner-occupants in city directories beginning around 1929, but they were members of the owner's family. From around 1937, renters who were not family members are listed in directories. By 1973, the separation had been formalized as units A and B.

PROJECT SPECIFICATIONS

The proposed project includes five parts:

- 1. Construction of a 4' deep front addition.
- 2. Reconstruction of the front porch to extend 4' beyond the front wall of the house. The porch will be 9' deep.
- 3. Rehabilitation of historic wood-sash windows if possible; replacement with 1:1 cladwood windows if rehabilitation is not possible.
- 4. Replacement of existing cladding with horizontal wood or hardiplank siding.
- 5. Changes to the window openings on the east (side wall).
- 6. Removal of the rear wall and rear west (side) wall; construction of a rear addition with 1- and 2-story portions. The 1-story portion will be clad in vertical wood or vertical metal siding to match existing and capped by a shed roof; the 2-story portion will be clad in vertical wood siding and capped by a front-gabled roof and set back 35' from the front wall of the house. Windows include clad-wood double-hung or casements. Features include a ground-floor carport bridged by the second story, a brick or stone masonry chimney on the west wall, and a roof deck. The addition has a footprint of just under 1,600 square feet.

STANDARDS FOR REVIEW

The property is contributing to the West Line Historic District. It does not appear to meet the standards for designation as a historic landmark.

Designation Criteria—Historic Landmark

- 1) The building is more than 50 years old.
- 2) The building appears to retain a high degree of integrity.
- 3) Properties must meet two historic designation criteria for landmark designation (City of Austin Land Development Code (Section 25-2-352). The property does not appear to demonstrate significance according to any of the criteria.
 - *a.* **Architecture.** The building is a good example of the National Folk style. It does not appear to be architecturally significant.
 - b. Historical association. James and Wilhelmina Turpen and Edward and Sadie Harris each lived in the house for approximately 20 years. There do not appear to be significant historical associations.
 - *c.* **Archaeology**. The property was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
 - *d.* **Community value**. The property does not appear to possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the community, Austin, or Texas as a whole.
 - *e.* Landscape feature. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

COMMITTEE RECOMMENDATION

Make the front porch at least 7' deep; preserve wing-and-gable shape; separate windows onto porch; retain as much historic fabric as possible.

The front porch is 9' deep, the wing-and-gable shape has been preserved, and windows onto the porch have been separated.

STAFF RECOMMENDATION

Approve the application, subject to completion of a City of Austin Documentation Package.

Background Research

James Aron Turpen lived at 1206 W. 10th Street from at least 1918 until his death in 1927, with one break in the mid-1920s. Born in 1877 in Texas, James Turpen grew up in a farming family in Montague, just south of the Oklahoma border. He worked for 20 years as the captain of Engine Company No. 4, located at the end of the 1200 block of W. 10th Street. He was promoted to fire inspector just before he died of pneumonia in 1927.

Wilhelmina Turpen lived in the house from at least 1918 until about 1935, with two breaks in the mid-1920s and early 1930s. Born Wilhelmina Krahe around 1879 in Germany, she immigrated to the United States at an unknown date. By 1898, she was living in Travis County, where she married James Turpen. The couple had six children, four of whom survived. After James Turpen died in 1927, Wilhelmina may have remarried, as her obituary lists her name as Wilhelmina Jennings (perhaps coincidentally, the surname of the family that occupied 1206 W. 10th Street by 1940, a few years after she moved out). She died in 1961 in San Bernadino, California.

Edward Lee ("Edd") Harris lived in the house from at least 1944 until around 1959. He was born in 1882 in Texas to a large farming family and grew up helping on the farm. As an adult, he worked as a tile helper for a few floor covering companies in Austin. Edward Harris died in 1965 in Travis County.

Sadie Beth Harris (nee Henderson) was born in 1896 in Pulaski, Tennessee. By the time she was 14, her family had moved to Texas and settled in Buda. Sadie married Edward Harris by 1913, and the couple had at least two children. Prior to moving to 1206 W. 10th Street, in 1940, the Harrises rented a house at 601½ W. 6th Street, housed Edward's father and Sadie's mother, and had a lodger, a 33-year-old divorced woman. Newspapers in 1942 mention the family as living in Manor. Sadie Harris died in 1972 in Austin.




