WAIVER REQUEST:

The applicant requests a waiver under 25-2-1081(A) to reduce the compatibility setback required by 25-2-1067(G).

PROJECT DESCRIPTION:

The applicant proposes a three-story, 74-unit multifamily residential building with associated detention, water quality, utility, sidewalk, parking, and landscape improvements.

STAFF RECOMMENDATION:


Staff recommends approval of the compatibility waiver request. The site plan will comply with all other requirements of the Land Development Code prior to its release.

SUMMARY STAFF COMMENT:

The applicant proposes a multifamily project on the site of an abandoned former nursing home (now demolished). The applicant has an approved site plan exemption (DA-2017-0845) which allows the existing parking (which predates the compatibility ordinance) to be maintained in its current extent. On the east side of the building between the extent of the existing parking and extent of the 25-foot compatibility setback there is a gap or strip of proposed pavement approximately 1.5 feet by 140 feet long for which a waiver is required.




