2. Public Communication: General

- Rémy Greinhofer: spoke in favor of dockless mobility service operators sharing Application Programming Interface (API) data with the City of Austin

Traffic Fatalities Reported Since Last BAC Meeting: Patricia Schaub read aloud the names of the eight people killed in traffic crashes on Austin streets since the BAC last met: Jesus Servantez, David Hillburn Sell, Ann Botten-Seago, Laura Wray, Anthony Diaz, Mark Sands, Trevor James Ralston, and Messiah Zion Mouton.

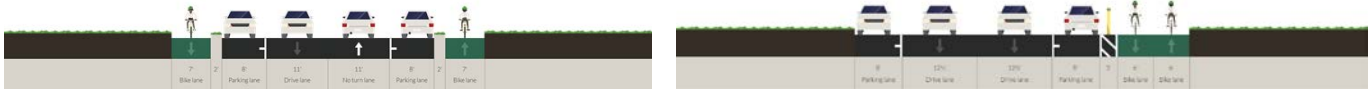
5. Parking Districts: Jason Redfern, Austin Transportation Department Parking Enterprise Division Manager, gave a [presentation](#) on [Parking Benefit Districts](#) and [Parking and Transportation Districts](#).

6. Recommendation Regarding the Implementation of Mobility Improvements to San Jacinto Blvd through UT Austin: Kathryn Flowers proposed draft recommendation language to the BAC which, after debate and amendment, read as follows: *NOW, THEREFORE, BE IT RESOLVED that the Bicycle Advisory Council (BAC) recommends the rapid*

implementation of mobility improvements to this section of San Jacinto that prioritize safety of people walking and biking above all other considerations, such as:

- the creation of protected bicycle lanes or a cycle track
- the elimination of private vehicle access and parking in the corridor
- bus curb control that does not conflict with other users
- raised crosswalks
- improved sidewalks;

BE IT FURTHER RESOLVED that the BAC recommends the immediate elimination of angled-in parking on this section of San Jacinto and the establishment of a temporary protected all ages and abilities bicycle and scooter facility until a permanent solution can be established, with two example cross sections given below:



BE IT FURTHER RESOLVED that the BAC recommends that Capital Metro establish a policy stating that the sharing of lanes between bicycles and transit vehicles is not safe for cyclists of all ages and abilities;

BE IT FURTHER RESOLVED that the BAC recommends the University of Texas adopt Vision Zero policy and create a Bicycle Master Plan in cooperation with the City of Austin in accordance with National Association of City Transportation Officials (NACTO) street design standards;

BE IT FURTHER RESOLVED that the BAC recommends the University of Texas expeditiously implement life-saving mobility improvements on areas within its jurisdiction to prevent the death of vulnerable populations including the students, faculty, and staff who put their trust in the institution every day to keep them safe.

The [recommendation](#) was adopted on Ortega motion, Alvarado second on a 7-0 vote with Alcorn and LeBlanc absent. Staff will share the recommendation with the appropriate UT Austin and Capital Metro staff.

Curtis Rogers proposed that the BAC sign on to a [joint statement](#) that Bike Austin is gathering signatures for. A motion to approve this action was adopted on Lentz motion, Heathcott second on a 7-0 vote with Alcorn and LeBlanc absent.
