21 22 23 24	(3)	On December 4, 2018, Council's Housing and Planning Committee voted to recommend establishing the Board of Directors, adopting a Final Project and Financing Plan, and increasing the tax increment from 10% to 20% for the Zone.

27 28	(1)	A Board of Directors is established, consisting of 11 members including one Chair, appointed by the City Council.			
29 30 31 32	(2)	Council appoints its members as the Board of Directors of the Zone, pursuant to Chapter 373A, Texas Local Government Code, and Chapter 311, Texas Tax Code.			
33 34	(3)	City Council appoints to serve as chairman of the Board.
