## ORDINANCE NO.

AN ORDINANCE ADOPTING THE AUSTIN STRATEGIC MOBILITY PLAN (ASMP) TO REPLACE THE AUSTIN METROPOLITAN AREA TRANSPORTATION PLAN AND 2025 ROADWAY TABLE; AMENDING THE IMAGINE AUSTIN COMPREHENSIVE PLAN; AND ESTABLISHING AN EFFECTIVE DATE.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1**. The Austin Strategic Mobility Plan (ASMP), attached as **Exhibit "A"** to this ordinance, is adopted as an amendment and attachment to and a component of the Imagine Austin Comprehensive Plan.
- **PART 2.** The ASMP serves as the transportation element of the Imagine Austin Comprehensive Plan, including Traffic Circulation and Mass Transit elements as named in the Austin City Charter. The transportation features of the Imagine Austin Comprehensive Plan maps shall be updated to reflect the ASMP.
- **PART 3**. The Imagine Austin Comprehensive Plan is amended to replace the Austin Metropolitan Area Transportation Plan (Ordinance No. 950309-G) and 2025 Roadway Table (Ordinance No. 010607-48 and all additions and amendments thereto) for all purposes with the ASMP. References in the Land Development Code to the Transportation Plan shall be construed as references to the ASMP and Street Network Table, with the following provisions:
  - (a) The primary format of the Street Network Table shall be a publicly accessible website (austintexas.gov/asmp) that will allow for future amendments to be efficiently incorporated.
  - (b) Right-of-way dedication requirements are included in the Street Network Table. Changes to adopted right-of-way requirements will be processed as formal amendments to the plan according to procedures set forth in the Austin City Charter.
  - (c) Specific roadway alignments within the City's planning jurisdiction shall be determined by the Director of the Austin Transportation Department or his successor in

function, except that any roadway addition, deletion, change of classification or change of alignment of more than one thousand five hundred (1,500) feet in any direction shall require an amendment to the Imagine Austin Comprehensive Plan.

**PART 4**. The Bicycle Master Plan, Vision Zero Action Plan, and Urban Trails Master Plan, previously attachments to the Imagine Austin Comprehensive Plan, will be included as part of the ASMP.

**PART 5.** The Sidewalk Master Plan/ADA Transition Plan, passed under Ordinance No. 20160616-072, will be included as part of the ASMP.

**PART 6**. This ordinance takes effect on \_\_\_\_\_\_\_\_, 2019.
