We are re-submitting the application for consideration for removing the City Historical Designation on the property and return it to it's orignal zoning of CS-1-NCCP-NP and future use of MU. I have picture to also show the current condition of the property and the lack of up keep making it a target for vandalism and an eye sore in the community and next to local retail businesses and restaurants in the area. The property has been unoccupied for several years and detoriation with water damage is evident through out the property. The property is secure and has an alarm. In further inspection it is obvious due to the weather it has been a place individuals are trying to get in for whatever reasons. I feel the
