HISTORIC LANDMARK COMMISSION MAY 20, 2019 DEMOLITION AND RELOCATION PERMITS HDP-2019-0212 1213 TAYLOR STREET

PROPOSAL

Demolish a ca. 1931 house.

ARCHITECTURE

One-story frame house with horizontal siding; partial-width gable-roofed porch; exposed rafter tails; single and paired 1:1 windows with wood screens; paired front doors. This vernacular structure displays a unique combination of Craftsman influences with a Cumberland-style double front door.

RESEARCH

The house appears to have been built around 1931 for Nora Maupin and her family. Maupin was the widow of longtime deputy sheriff Amos Maupin, who died suddenly in 1931. Maupin's daughter Josephine Clark and her husband Morris, a carpet salesman, also lived in the house for about 16 years. Morris Clark's family owned the house at 1206 Taylor Street, which may have influenced the Maupin family's move to the neighborhood. The house's double-door entry, usually seen in older homes, may have been a deliberate choice by the owner to accommodate the needs of her blended family. In 1932, Nora Maupin's daughter Cora passed away; her son Bobby Joe came to live with his grandmother and aunt as well. Bobby Joe, an electrician, lived with his grandmother until at least 1962. Nora Maupin continued to live in the house until her death in 1972.

By 1973, the house was occupied by Fidel and Eva Cisneros. Fidel Cisneros was a plasterer and construction worker. Both Eva and Fidel Cisneros were lifelong Austinites. Deed records indicate that the couple and their family owned the house until 2018.

STAFF COMMENTS

The house is recommended as contributing to a potential historic district in the East Austin Historic Resource Survey (2016).

Designation Criteria—Historic Landmark


- 1) The building is more than 50 years old.
- 2) The building appears to retain moderate to high integrity. Entry doors and porch posts may have been replaced.
- 3) Properties must meet two historic designation criteria for landmark designation (City of Austin Land Development Code, Section 25-2-352).
 - a. *Architecture.* The house is a frame mid-1920s vernacular bungalow with Craftsman stylistic influences and a Cumberland-style double entrance. While not stylistically significant aside from its uncommon entrance configuration, the house does reflect the architectural style of the time it was built, and would be integral to the preservation of the character of Taylor Street, a remarkably intact block just east of the freeway.
 - b. *Historical association*. While the house is associated with two long-term residents of Taylor Street, it does not meet the criterion for significant historical association.
 - c. *Archaeology*. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.

- d. *Community value*. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
- e. *Landscape feature*. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. While this house may not qualify as a historic landmark on its own merits, removing it should be a last resort to adaptive re-use and rehabilitation that would encourage the preservation of the historic character of this unusually intact street.

TWO AUSTINITES CLAIMED BY DEATH

Amos Maupin, 62, Travis county peace officer for many years and deputy sheriff under three sheriffs, died suddenly at 7:15 a. m. Saturday following an attack of acute indigestion at the home of Judge Emmett White at Cedar Valley.

Maupin had been complaining for some time of a stomach ailment, associates said.

He had been sent to the White home at Cedar Valley by Sheriff Coley Whilte, and had stopped his car and backed it into the yard, when Judge White noticed Maupin slump over the steering wheel.

Funeral Services Sunday

White and others at the place washed Maupin's face with water, attempting to revive him, but he never recovered, Judge White said.

Maupin is survived by his widow, two daughters, Mrs. Josephine Clark and Miss Cora Maupin, and one sister, Mrs. Hamilton Reilly, all of Austin.

Funeral services will be held Sunday at 4:50 p. m. from St. Mary's Catholic church with Rev. J. J. O'Rourke officiating, according to an announcement from Cook's funeral home where the body was taken. Until the funeral hour the body will be at the family home, 1006 Taylor street.

Pallbearers will be Sheriff Coley White and Dep. Sheriffs Milton Boring, Paul Blair, Homer Thornberry, C. R. Redding, and T. P. Lock. Burial will be in Mt. Calvary cemetery. Courthouse Closed

Out of respect to Maupin offices in the Travis county courthouse were closed at noon Saturday for the remainder of the day.

For many years he served as a deputy constable here, and was a deputy under Sheriff Coley White for four years. Horace Burleson and George Matthews.

Maupin was of the picturesque "peace officer" type of the early days, effecting a drooping mustache and the ever present widebrimmed hat. He spoke with a drawl and was always courteous to visitors to the sheriff's offices.

Kept Bloodhounds

Only several years ago, the department here purchased some bloodhounds for use in raids on stills in the hills west of the county and Deputy Maupin was established as "meeting of the bested".

stills in the mile west of the county and Deputy Maupin was established as "master of the hounds," "This just isn't the day for bloodhounds," he often remarked, "Before we had automobiles it was different, but the dogs don't come in for much service nowadays."

A familiar figure at the courthouse for many years, Maupin could be seen almost every day that county court was in session, leaning near the judge's bench in the capacity of balliff.


