Chapter 2254 of the Local Government Code requires that municipalities comply with the procedures established for the selection of professional consulting services such as engineering, architecture, landscape architecture, surveying, or planning services in design or planning of a construction project. Section 2254.003 states that the municiaplity must select a provider of professional services or award a contract only on the basis of demonstrated competence and qualifications to perform the services and for a fair and reasonable price. Departments requesting the use of this exemption must provide documentation of the use of a Qualifications-Based Selection process in selecting the firm.

The McDougalls have retained Hayward Baker Inc. of Little Elm Texas to perform preliminary engineering design of a solution to stabilize and repair the damaged area. The City reviewed Hayward Baker's qualifications during the qualifications-based selection process conducted by the City in June and July 2018. The selection panel determined that Hayward Baker Inc. is qualified to perform this work. As stated in the attached Agreement, "The McDougalls and the City have agreed that...It is beneficial to both the City and the McDougalls that, for the sake of expediency, the McDougalls contract for the preliminary engineering design of a solution to stabilize and repair the damaged areas."

Because the above facts and documentation support the requested exemption, the City of Austin intends to contract with Michael and Bremond McDougall

BEFORE ME, the undersigned authority, personally appeared Michael L. Personett who being by me first duly sworn, upon path deposed and stated: "My name is Michael L. Personett, I am over eighteen (18) years of age. I am the Interim Director of the City of Austin Watershed Protection Department. I have personal knowledge of the facts set forth below and am competent and authorized to make this affidavit.

On May 4 and 5, a landslide occurred on a bluff adjacent to Shoal Creek between 24th Street and Shoal Creek Boulevard. The landslide affected both private property and City of Austin Park property known as the Shoal Creek Green Belt. The landslide destroyed a portion of a Hike and Bike Trail and a 30-inch diameter wastewater line. The landslide also created a blockage consisting on landslide debris in the Shoal Creek channel. The landslide poses an ongoing threat to public safety in three important ways: 1) the landslide material is unstable and additional soil movement or rockfall could occur in the Shoal Creek Greenbelt at any time, 2) landslide material in Shoal Creek is impeding the conveyance of flow creating an increased risk of flooding in the area and, 3) while the damaged wastewater line is out of service there is an increased risk of wastewater overflow into the creek. It is necessary to enter into agreements necessary to preserve property and protect the public safety. The situation requires the City engage contractors and consultants, including contractors specializing in the stabilization and repair of landslides. Therefore, in my opinion, contracting should proceed on an emergency basis under Chapter 252 of the Texas Local Government Code.

The situation described above is a threat to public health and safety that requires the immediate appropriation of money and procurement of specialized construction and engineering services. I believe that the landslide poses an imminent and ongoing danger to both public and private properties and necessitates emergency repair immediately. "Further Affiant sayeth not."
