30 conducted two public hearings to obtain public input for the development of the

32 Local Government Code Section 373.066(4) and Part 91, Title 24 of Code of Federal  
33 Regulations; and

34 **WHEREAS**, on January 8, 2019 and February 12, 2019, the Community  
35 Development Commission conducted public hearings to obtain public input for the  
36 development of the proposed Consolidated Plan and annual Action Plan, in  
37 accordance with Texas Local Government Code Section 373.006(4) and Part 91,  
38 Title 24 of the Code of Federal Regulations; and

39 **WHEREAS**, on May 14, 2019, the Community Development Commission  
40 conducted a public hearing to obtain public comment on the proposed  
41 Consolidated Plan and Annual Action Plan, in accordance with Texas Local  
42 Government Code Section 373.006(4) and Part 91, Title 24 of the Code of Federal  
43 Regulations; and

44 **WHEREAS**, beginning April 16, 2019, the City Manager made the  
45 proposed Consolidated Plan and annual Action Plan available for a 30-day public  
46 comment period ; and

47 **WHEREAS**, on May 14, 2019, the Community Development Commission  
48 made its final recommendation on the proposed Consolidated Plan and Annual  
49 Action Plan; **NOW, THEREFORE**,

50 **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

52 In accordance with federal and state law, the City Council approves Exhibit  
53 A (Consolidated Plan and Annual Action Plan), Exhibit B (Change Log), and Exhibit  
54 C (Funding Table), which are attached to this resolution, as the City's Consolidated  
55 Plan for Fiscal Years 2019-2014 and Annual Action Plan for FY 2019-2020.

57 **BE IT FURTHER RESOLVED:**

59 The City Council authorizes the City Manager to submit applications, a final  
60 statement of community development objectives, and projected use of funds, and  
61 any required certifications, and to negotiate with HUD for the Federal HUD Grant  
62 before August 15, 2019.

64 The City Council further authorizes the City Manager to prepare, execute,  
65 attest, and deliver all documents necessary to carry out the purposes of this  
66 Resolution.
