Public notice was given for this solicitation CLMC734 West Allandale and Trailridge Drive Utility Line Renewal, through the City's Vendor Connection web portal. Eight bids were received and opened on March 14, 2019. Of the eight bids received four bids were from MBE/WBE certified firms. Santa Clara Construction, Ltd submitted the lowest responsive bid of eight bids received including allowances in the amount of \$140,000:
