- 4. Briefing on the Inspection Frequency Standard (IFS), a risk-based approach to inspections for eating establishments and lemonade stands, and fee exemption for nonprofit subcontractors.**

*The Austin Public Health Department proposed a new fee schedule to be presented later in 2018 along with the department's budget. This new fee schedule would be implemented on October 1, 2018 pending Council's support. Also discussed was the new fee exemptions for*



*nonprofit subcontractors that would begin soon. Don Hastings, Assistant Director of the Environmental Health Services Division of the Austin Public Health Department presented. Greater Austin Restaurant Association (GARA) members Skeeter Miller and Hoover Alexander, who provided input on this proposal, spoke in support of the new fee schedule, and would like to continue to work on it with the department. Committee Members support moving forward with the proposal.*

**5. Briefing on recent smoking ordinances passed in San Antonio.**

*Statistics on leading causes of death, focusing on lung cancer as the number one killer of men and women in Travis County, and San Antonio's Tobacco 21 ordinances were presented by Austin Public Health Department Medical Director, Dr. Philip Huang.*
