PROPOSAL

Demolish a ca. 1915 duplex.

ARCHITECTURE

Two-story, rectangular-plan, hipped roof frame duplex with single 4:4 fenestration and small hoods over the entries to the building. The 1935 Sanborn map shows it as a two-story wooden structure with a 1-story porch across the front.

RESEARCH

The duplex appears to have been built around 1915 and has had some fairly prominent long-term tenants over the years. The first known tenant was Henry Greene, a watchmaker for Joe Koen, a downtown jeweler. Henry Greene moved from here to Fort Worth, where he became a jeweler. In the early 1920s, it appears that the entire structure was rented by members of the Nivens family, who owned a sporting goods store downtown. Mollie Johnson, a single woman, purchased the house in the late 1920s, and lived here until the mid-1930s. In the late 1940s through the mid-1950s, Dorothy Journeay, a librarian at the Texas State Library, lived in Apartment A. Since the late 1950s, there have been more students renting the apartments in this house. It was converted to offices in the mid-1980s.

STAFF COMMENTS

The duplex is contributing to the West Line National Register Historic District.

STANDARDS FOR REVIEW

Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The duplex is a simple box-like structure that appears to be very much intact; however, the structure is reminiscent of garage apartments in its configuration and appearance, and as such, constitutes a common style in the city. The distinguishing characteristics of the building are its 4:4 windows which reveal its age.
 - b. **Historical association.** The house was either built as, or quickly converted to a duplex use that had some prominent tenants for relatively long periods of time; however, none of the tenants on their own would qualify the house for landmark designation due to significant historical associations.
 - c. **Archaeology.** The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
 - d. **Community value.** The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.
 - e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The permit cannot be released until the Commission has reviewed plans for new construction, so staff encourages the applicant to seriously consider whether demolition of this building, which appears to be in very good condition, is truly necessary.

BIOGRAPHICAL NOTES

Samuel H. and Alice Nivens (ca. 1921 – ca. 1926)

Samuel H. and Alice P. Nivens are listed in the 1920 U.S. Census as the renters of the house at 1811 S. Congress Avenue. Samuel H. Nivens was 67, had been born in Missouri to Tennessee-born parents, and had no occupation listed. Alice P. Nivens was 59, had been born in Texas, and had no occupation listed. They had 6 children living with them: Frank, 40, a fiscal agent for the government; Mabel E., 32, who had no occupation listed; Samuel H., 27, a salesman in a hardware store; Jane, 23, a public school teacher; Charley, 22, a salesman in a hardware store; and Moody, 19, a ranchman on a sheep ranch. All the children had been born in Texas.

The 1930 U.S. Census shows Samuel H. and Alice Nivens as the renters of the house at 1018 Bonham Terrace in Travis Heights. Samuel H. Nivens was 77, had been born in Missouri, and had no occupation listed. Alice P. Nivens was 69, had been born in Texas, and had no occupation listed. A son, Frank W. Nivens, 51, had been born in Texas and worked as a book-keeper for a hardware store.

Samuel Henry Nivens was living at 1018 Bonham Terrace at the time of his death in 1937. He was born in 1852 in Jackson, Missouri, and was a retired merchant. Alice Nivens was living at the Bonham Terrace house at the time of her death in 1947. She was born in Hays County, Texas in 1860 and was a widowed housewife.

Mollie Johnson (ca. 1926 – ca. 1937)

The 1930 U.S. Census shows Mollie Johnson as the owner of this house, which was worth \$5,000. She was a 72-year old single woman who had been born in Texas to a Virginia-born father and an Ohio-born mother, and had no occupation listed. She lived alone.

Mollie Johnson was living at this address at the time of her death in 1937. She was born in 1856 in Texas, and was single. She had no occupation listed on her death certificate.

Dorothy C. Journey (ca. 1946 – ca. 1955)

Dorothy Journey appears in the 1930 U.S. Census for Houston, Texas. She was married to William H. Journey, and they lived with William's father, James Journey, a 78-year old widower.

Dorothy Journey was 32, had been born in France to an English-born father and a Texas-born mother, and had no occupation listed. Her husband, William, was a 40-year old Texas-born office man for a lighting and electrical concern.

The 1940 U.S. Census shows Dorothy C. Journey as a 35-year old French-born librarian in the Texas State Library in Austin. She had lived in Houston in 1935. With her lived her mother, Elizabeth V. Cotton, an 82-year old Texas-born widow with no occupation listed who had lived in Dallas in 1935; and her sister, Stella B. Cotton, 39, who had been born in England, and lived in Dallas in 1935. Dorothy was the only one in the household with an occupation.




