SUBJECT Recommend approval to authorize award of a multi-term contract with Shrieve Chemical Company, to provide anhydrous ammonia, for up to five years for a total contract amount not to exceed \$1,600,000.						
	AMOUNT AND SOURCE OF FUNDING					
Funding in the amount of \$53,333 is available in the Fiscal Year 2018-2019 Operating Budget of Austin Water. Funding for the remaining contract terms are contingent upon available funding in future budgets.						
Purchasing Language:	The Purchasing Office issued an Invitation for Bids (IFB) 2200 GLB1020REBID for these goods. The solicitation issued on May 6, 2019 and it closed on May 30, 2019. The recommended contractor submitted the only responsive offer. MBE/WBE:	This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established					

The contract will provide anhydrous ammonia for Austin Water plants. Anhydrous ammonia is mixed into chlorinated water to form chloramines, the secondary disinfectant utilized in potable drinking water treatment at the water treatment plants. The use of chloramines as the secondary disinfectant is required to limit the formation of byproducts in the disinfection process. This product complies with National Sanitation Foundation Standard 60 which governs the use of direct additives for treatment of drinking water.

This contract will replace a current contract which expires September 9, 2019. The requested authorization amount was determined using estimates of increased annual usage and historical spending. The recommended contractor is the current provider for these goods.

PRICE ANALYSIS

- a) Solicitations: 106 notices were sent, including 2 MBE and 2 WBE firms, 1 responsive bid was received with no M/WBE firms responding.
- b) Cost Analysis: The proposed contract represents an approximate 8% increase in unit cost from the previous contract. The index supports a 13.9% increase.
