### **Posting Language**

Authorize an amendment to the construction contract with Alpha Paving Industries, LLC (MBE), for the Annual Asphalt Repair Contract 2018 (South) Indefinite Delivery/Indefinite Quantity contract for additional funding in the amount of \$562,500, for a total contract amount not to exceed \$2,812,500.

[Note: This contract was awarded in compliance with City Code 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program). Current participation to date is 60.98% MBE and 0.00% WBE.]

### **Additional Backup Information:**

This Indefinite Delivery/Indefinite Quantity contract involves the repair of temporary asphalt applied after emergency Austin Water utility line repairs in south Austin. The Public Works Department also performs these repairs, but the volume of work is larger than City crews can complete.

Due to a high volume of work and the need to repair roadways quickly, additional funding is required for this contract. A new Asphalt Repair Indefinite Delivery/Indefinite Quantity contract is being prepared and should be solicited later this year.

The Small and Minority Business Resources Department is closely monitoring this project and has

communicated directly to the contractor regarding its Women-Owned Business Enterprise (WBE) participation for this contract.

This amendment has been approved by the City's Change Control Committee. The Change Control Committee was established to comply with Council Resolution No. 20120126-048, which required the establishment of consistent criteria and process to evaluate contractual changes for all contracts administered by the Capital Contracting Office. The Change Control Committee is comprised of management-level subject matter experts.

The project will be managed by Public Works Department.
