

REGIONAL AFFORDABILITY COMMITTEE MINUTES

REGULAR MEETING WEDNESDAY, MAY 22, 2019

The Regional Affordability Committee convened in a regular meeting on Wednesday, May 22, 2019 in the Boards and Commissions Room at City Hall, 301 W. 2nd Street in Austin, Texas.

1. APPROVAL OF MINUTES

3. Strategic Initiative 1 – Affordable and Attainable Housing: Briefing and discussion by the Austin Tenant's Council on evictions in Central Texas.

Jeanie Nelson and Daniel Armendariz with the Austin Tenant's Council spoke on evictions on Travis County. They spoke on the number of evictions compiled in 2015 and how that might relate to the current number of evictions, which is being compiled. They walked through the process of evictions, and the issues in the process that their office sees. Noted that the Council could use volunteers to help with their programs.

FOLLOW UP: Build a map of asset maps for these types of programs (Travillion). Information what the local agencies can do versus what must be done at the state level.

 - Ed Van Eenoo, Deputy Chief Financial Officer, gave an update on the impact of the State Legislature's proposed bills in the current legislative session. He discussed how the bills would impact the City of Austin from a financial perspective.
