

Animal Advisory Commission Report Q2 2019

This report is intended to give a high level overview of Austin Pets Alive!'s lifesaving operations each quarter, with a focus on APA!'s impact on Travis county through our partnership with Austin Animal Center.

Intakes - Compared to Q2 2018, APA transfers from AAC were up 52% for cats, 28% for dogs and 43% overall in Q2 2019.


Total Cat Transfers from AAC



Intakes from AAC - Cat Breakdown




Intakes from AAC - Dog Breakdown





^{*} UDIC = Unassisted Death in Custody is comprised of animals pulled with severe medical concerns or neonates who died while receiving appropriate care for their life-threatening condition.

Significant numbers and highlights from Quarter 2

Statistics of note:

- 160% increase in cat bottle baby intakes over 2018 (397->659)
- 240% increase in med/large dog space pulls over 2018 (85->296)
- 300% increase in dog bottle baby intakes over 2018 (24->76)

In April, a "Kitty Committee" meeting was held with representatives from AAC, APA!, and AHS, to discuss last season's difficulties and successes, update protocols, and streamline processes between organizations in preparation for summer. Follow up meetings have since occurred to check in on these updates and discuss further challenges, and there is overall positive feedback from the teams on the process improvements so far.

Our required annual State Veterinary Inspection occurred on May 16, 2019. All four APA!-managed locations (TLAC, Tarrytown Dog, Tarrytown Cat, and Tarrytown Nursery) passed inspections and were endorsed by the Texas Department of State Health Services on June 3, 2019.

APA! worked closely with AAC for the city-wide 500-homes marketing push at the end of June. We coordinated a pull of over 80 additional animals to APA! in one day, and collaborated on a marketing strategy that helped send almost 600 animals to new homes in one weekend between APA!, AAC, and AHS.

Live Release Rate Calculations

Live Release Rate is calculated as AACs total live outcomes, which is all outcomes less Died, Euthanasia and Disposed, divided by total outcomes for the period.

AAC Live Release Rate without APA attempts to show what AAC might look like without transfers to APA. While there is no perfect way to calculate this metric since it is impossible to know what would have happened were these animals not pulled by APA, this is one way to illustrate APA's effect on AAC live outcomes.
