PROPOSAL

Demolish a ca. 1947 house.

ARCHITECTURE

One-story rectangular -plan, front-gabled concrete block residence with round-arched replacement window; front-gabled projecting bay contains a partially-enclosed portico with round-arched openings, lending a hint of Spanish Colonial Revival design to the house. It appears that the projecting bay was added to the house in either 1968, when there was a permit to construct a metal front porch (the existing front porch is not metal) or 1980, when city record indicate a permit for an addition.

RESEARCH

The house was built in 1947; the first owners and occupants were Herman and Lois Peavy, who lived here for only a short time. There was a series of renters in the house until 1964, when the house was purchased by Frank Parra Goodman, and his wife, Elizabeth. Frank Parra Goodman was a long-time employee of various furniture stores in Austin, then opened Goodman's Furniture Store as his own business. Goodman was very active in various philanthropic activities in Austin, and was honored for his work among bed-ridden veterans in local hospitals. He was also very influential in the South Congress business district, where he had his furniture store, campaigning for the city's Christmas lights to be extended south across the bridge from downtown along South Congress Avenue. Frank Parra Goodman and his wife, Elizabeth, who had been the office manager for his furniture store prior to their marriage, lived here until around 1995.

STAFF COMMENTS

The house has not been included in any City survey to date.


Staff has evaluated this house for designation as a historic landmark and has determined that the house does not meet the criteria for landmark designation as set forth in City Code:


- a. **Architecture.** The house is a concrete block structure with no architectural distinction. There have been additions and modifications to the front of the house, done by the most significant owner, but which have compromised the integrity of materials and design from its original appearance. The 1962 Sanborn map shows the house without the current front porch, and it appears that the windows on the front have also been modified and replaced.
- b. **Historical association**. The house was the long-time home of Frank Parra Goodman and his wife, Elizabeth. Frank Parra Goodman was a philanthropist, decorated veteran, and business leader on South Congress Avenue.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the neighborhood, or a particular demographic group.

e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

STAFF RECOMMENDATION

This house has been so modified that rehabilitation and re-use should focus on restoring the historic appearance of the house, which is unlikely. Staff recommends release of the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house does not meet the criteria for individual designation as a historic landmark.

BIOGRAPHICAL NOTES

Frank P. and Elizabeth M. Goodman (ca. 1964 – ca. 1995)

Frank P. and Ruth Goodman appear in the 1930 U.S. Census as the owners of the house at 1014 W. Milton Street in Austin. Frank P. Goodman was 29, had been born in Texas to Mexican-born parents, and was a concrete worker. Ruth Goodman was 27, had been born in Nebraska, and had no occupation listed. They had no children listed with them.

The 1940 U.S. Census shows F.P. and Ruth Goodman living in a house they owned at 1016 West Milton Street in Austin. F.P. Goodman was 40, had been born in Texas, and was a retail furniture salesman. Ruth Goodman was 37, had been born in Nebraska, and had no occupation listed. They had a daughter, Mary A., 4, who had been born in Texas.

Ruth G. Goodman died in September, 1977. She was living at 406 Crockett Street in Austin at the time of her death. She was born in Omaha, Nebraska in 1902, and was a retired foster grandparent for the State of Texas. She was divorced.

Frank P. Goodman's 1942 World War II draft card shows that he was born in El Paso, Texas in 1901 and was living in Austin at the time of his registration. He was 5'-5" tall, weighed 152 pounds, and had a light complexion with brown hair and brown eyes. He was employed by the Brown Furniture Company. His next of kin was Al Karotkin, the manager of the Karotkin Furniture Company on Congress Avenue.

Frank Parra Goodman married M. Elizabeth Mary Gutierrez in Travis County in September, 1961.


Goodman Honored For Hospital Work

Frank P. Goodman of Austin was commended for his "extraordinary good work in helping the confined veterans in VA hospitals in Tem-ple and Kerrville" in a citation awarded him Sunday at the state convention of the Military Order of Cooties in Galveston.

It was the first such citation to be given in the United States, Goodman is hospital chairman for the local Coolies chapter, a di-vision of the Veterans of Foreign Wars.

The certificate was presented by C. V. Schermacker of San Antonio, supreme hospital commissioner for the fifth district, Military Order of Cootles.

mated \$25,000 worth of furniture and paint was destroyed in the blaze, plus heavy damage to the building. The fire apparently started from faulty wiring.

Furniture Store Swept By Early Morning Fire

Fire raged through the Goodman Furniture Company, 1500 South Congress, early Saturday, destroying an estimated \$25,000 worth of furniture and paint.

Frank Goodman, owner, said the fire started at 12:48 a. m., apparently from faulty wiring. It began on a small balcony in the

rear and spread quickly throughout the store.

Firemen battled this blaze—the second major fire in Austin this week—for over three hours. They worked until 4:30 a.m. before extinguishing all the smoldering fire.

Goodman said over \$3,000 in floor covering, linoleum and carpeting was destroyed. The fire also burned several dining room and living room suites, cook stoves, refrigerators, and dozens of small tables and lamps.

Over \$2,000 worth of paint was destroyed.

Seven fire units fought the fire. Earlier this week, Allan Junior High burned with a loss estimated at \$500,000.

The fire completely destroyed the second-floor balcony and burned out most of the ceiling of the entire store.

Neither Goodman nor fire department officials would estimate the dollar damage to the building, but they both said it was "heavy."

The flames did not get outside the building, but burned out most of the wood material under the slate-rock roof.

Goodman said everything in this store—a large area stacked solid with furnishings and appliances—was damaged so badly it could not be sold.



City records indicate a complaint that the house was abandoned in September, 1999 with the roof caving in; the City ordered repairs to minimum standards and noted that the house was vacant.



The house appears on the 1962 Sanborn map, the first to show this section of Travis Heights. The map indicates that the house is constructed of concrete block. The current porch addition to the front of the house is not shown on this map.
