5 **AN ORDINANCE ACCEPTING GRANT FUNDS FROM THE TEXAS**  
6 **DEPARTMENT OF PUBLIC SAFETY AND AMENDING THE FISCAL YEAR**  
7 **2018-2019 OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE**  
8 **NO. 20180911-001) TO APPROPRIATE THESE FUNDS FOR REPAIRS TO CITY**  
9 **FACILITIES AND REPLACEMENT OF CITY PROPERTY DAMAGED OR**  
10 **DESTROYED BY THE FLOODING OF OCTOBER 2015, AUGUST OF 2017,**  
11 **AND OCTOBER OF 2018; AND AMENDING THE FISCAL YEAR 2018-2019**  
12 **CAPITAL BUDGET (ORDINANCE 20180911-001) TO TRANSFER IN AND**  
13 **APPROPRIATE GRANT FUNDS FOR REPAIRS TO CITY FACILITIES AND**  
14 **REPLACEMENT OF CITY PROPERTY DAMAGED OR DESTROYED BY THE**  
15 **FLOODING OF OCTOBER 2015, AUGUST OF 2017, AND OCTOBER OF 2018.**

17 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

19 **PART 1.** Council accepts grant funds from the Texas Department of Public Safety in the  
20 amount of \$1,314,087 for repairs to City facilities and replacement of City property  
21 damaged or destroyed by the flooding of May and October 2015, August of 2017, and  
22 October of 2018.

23 **PART 2.** Council amends the Fiscal Year 2018-2019 Operating Budget Special Revenue  
24 Fund (Ordinance No. 20180911-001) to appropriate \$1,314,087 for the following  
25 departments: Austin Energy \$6,681, Austin Fire Department \$153,673, Austin Police  
26 Department \$320,841, Austin Water \$17,073, Emergency Medical Services \$16,024,  
27 Homeland Security and Emergency Management \$24,628, Parks and Recreation  
28 Department \$2,027, the Public Works Department \$773,140, for repairs to City facilities  
29 and replacement of City property damaged or destroyed by the flooding of October 2015,  
30 August of 2017, and October of 2018.

31 **PART 3.** Council amends the Fiscal Year 2018-2019 Capital Budget (Ordinance No.  
32 20180911-001) to transfer in and appropriate \$773,140 from the Operating Budget  
33 Special Revenue Fund for the Public Works Department's Falwell Lane project.
