SUBJECT: Resolution No. 20190523-029 – Response re: Rainey Street District Fund

This memo is in response to Resolution No. 20190523-029 directing the City Manager to provide a report concerning deposits in the Rainey Street District Fund. The resolution specified that the report should provide the amount that would have been in this fund had right of way, alley vacation, and license agreement fees been deposited since 2013. Additionally, the report should account for city investments in the Rainey Street District during the same period. This investment data took additional time to gather delaying this response.

From FY 2013-2019 year-to-date, \$600,000 has been deposited into the Rainey Street District Fund as prescribed by Ordinance No. 20131024-010. The Austin Transportation Department (ATD) provided \$506,775 in right-of-way fees while the Office of Real Estate Services (ORES) provided the remaining \$93,225 from alley vacation and license agreement fees. If the same deposits had continued beyond the \$600,000 ceiling set in Ordinance No. 20131024-010, an additional \$1,724,908 from ATD and \$54,347 from ORES, for a combined total of \$1,779,255, would have been added to the Rainey Street District Fund.

Regarding investments made in the Rainey Street District (the "District"), several departments have made numerous infrastructure and capital investments in the District over the same time. The following table lists the type of investments meeting the criteria set forth in this Resolution and the funding amount. Funding for major public infrastructure projects such as the Waller Creek Tunnel, chilled water and transmission lines, and rehabilitation and replacement of water and wastewater lines, are <u>not</u> included with this project list.

The Resolution also directed the City Manager to return to Council by June 20 with an ordinance that requires funds from **right-of-way fees**, **alley vacation sales**, **and license agreements for developments** within the Rainey Street Historic District to be deposited into the Rainey Street District Fund. The City Manager was directed to provide a positive or negative recommendation on the ordinance based on additional information including:

- a. Previous investments made in the Rainey Street Historic District (see table above),
- b. Needed investments in the Rainey Street Historic District (see attached table),
- c. Citywide funding needs and strategic priorities, and
- d. An analysis of equity in city investments, recognizing the importance of safe access to the Mexican American Cultural Center and Fifth Street Mexican American Heritage Corridor as well as the importance of investing in communities of color currently underserved by the City.

City-wide funding needs and strategic priorities will be presented as part of the FY 2020 Proposed Budget. There was not sufficient time to complete the requested analysis of equity in city investments.

At this time, we do not recommend establishing a permanent set aside of revenues for a specific purpose. Best financial practices focus on consideration and evaluation of overall city-wide needs prior to prioritizing a specific project or program need. This set aside, if acted on June 20, would occur before staff and Council's budget discussions and consideration of overall City priorities and weighing of this action against such overall priorities. Given the uncertainty of future budgetary changes due to recent State action to cap property tax rate increases, we should preserve all available revenue streams until staff and Council can have broader budgetary discussions.

As requested, a proposed Ordinance will be on the June 20 Addendum Agenda for Council's consideration. It is my recommendation Council defer action on this ordinance until it can be considered as part of the FY 2020 budget adoption.
