Posting Language

Authorize amendments to existing cooperative contracts with GT Distributors, Inc., and Precision Delta Corp., to provide ammunition, for an increase in the amount of \$1,030,000, and revised total contract amounts not to exceed \$2,291,000 divided between the contractors.

(Note: The contract award was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. No subcontracting opportunities were identified; therefore, no subcontracting goals were established).

Additional Backup Information:

The proposed amendments to increase authorization on the contracts will allow the Austin Police Department (APD) to continue to purchase ammunition for APD officers and cadets, for use while on duty, during firearms trainings, and for required annual qualifications. All APD officers are required by State statutes and departmental policies to qualify annually with each weapon they are authorized to carry, including handguns, shotguns, and rifles. These contracts do not have enough authorization to continue the purchasing of ammunition for APD due to underestimated initial projections.

If the proposed amendments are not approved, APD will be non-compliant with Texas Commission on Law Enforcement rules for having an inadequate amount of ammunition available for the line of duty and an

inadequate amount of ammunition available to conduct required firearms trainings for cadets and mandatory annual qualifications for officers.
