# **Project Summary**

The City of Austin Art in Public Places (AIPP) program of the Cultural Arts Division, Economic Development Department seeks to commission a durable, permanent exterior public artwork that creates a sense of identity and a sense of positivity through color, imagery and engagement with the nearby communities.

# **Public Art Goals & Priorities**

The Art in Public Places program seeks to commission works of art of redeeming quality that advance public understanding of visual art and enhance the aesthetic quality of public places through the selection of a qualified artist or artist team who can innovatively and thoughtfully design within the context of this project. The goal of the Ricky Guerrero Pocket Park AIPP Project is to select an artist/artist team who will design artwork that:

- cultivates an uplifting perspective through color, imagery or design;
- strengthens the identity of the park and enlightens the viewer about Ricky Guerrero and/or the neighborhood;
- demonstrates engagement between the artist and the nearby community; and
- is easily maintained and vandal resistant in an exterior environment.

# **Budget**

The AIPP 2% funding for this project comes from the 2012 Bond. The total award for an artist contract is **\$31,000**, inclusive of design, fabrication and installation, including engineering and permitting fees, travel and shipping expenses, insurance and other project-related costs.

A Request for Qualifications was distributed on May 7, 2019 to professional visual artists who live and work in Williamson, Travis, Bastrop, Caldwell, Hays, Burnet and Blanco counties. Applications were submitted through PublicArtist.org by the deadline of June 20, 2019. The City of Austin Art in Public Places Panel convened a selection panel to evaluate the submissions. On August 8, 2019 the selection panel and advisors reviewed qualifications and selected four finalists for interviews, in no particular order, Gigi Miller, Emily Weiskopf, Ernesto Hernandez and Rejina Thomas. The selection panel and advisors convened on August 20, 2019 for interviews and selected one artist and two alternates. Gigi Miller was selected as the artist and Emily Weiskopf was selected as the alternate with Ernesto Hernandez as the second alternate. This recommendation will be presented to the Art in Public Places Panel and Arts Commission for approval.
