## 1. How to treat creeks and rivers and areas along them

Category 1: Immediate Effect (Ordinance Section (B)(3), page 3)

(3) in the bed or on the bank of a creek or river

[ALTERNATIVE: and within 5 feet of the top of the bank of a creek or river];

# 2. How to treat high wildfire areas

Category 1: Immediate Effect (Ordinance Section (B)(5), page 4)

(5) on land that the city has designated as having a high fire risk, and that is marked with city no-camping signage

[ALTERNATIVE: no lighting fires in high risk fire areas];

#### 3. How to treat sidewalks and streets

Category 1: Immediate Effect (Ordinance Section (B)(6), page 4)

[ALTERNATIVE: along high pedestrian and vehicular traffic roadways identified by the Austin Transportation Department.]

Category 1: Immediate Effect (Ordinance Section (B)(7), page 4)

(7) on a sidewalk in a way that doesn't:

[ALTERNATIVE: leave a 4-foot clear zone.] [ALTERNATIVE: leave a 5-foot clear zone.]

[ALTERNATIVE: allow an area necessary for safe pedestrian use of the sidewalk based on transportation safety standards used by Austin Transportation Department.]

Category 2: After Signage (Ordinance Section (D)(8) and (9), page 5)

- (8)[ALTERNATIVE on the following streets and associated right-of-ways:
  - i. Rio Grande Avenue from Martin Luther King Jr. Blvd to 26<sup>th</sup> Street
  - ii. San Antonio Avenue from Martin Luther King Jr. Blvd to 26<sup>th</sup> Street
  - iii. San Gabriel Street from Martin Luther King Jr. Blvd to 26<sup>th</sup> Street
  - iv. Nueces Street from Martin Luther King Jr. Blvd to 26<sup>th</sup> Street
  - v. Red River Street to Cesar Chavez Street to 12th Street];
- (9)[ALTERNATIVE along high pedestrian and vehicular traffic roadways identified by the Austin Transportation Department, including associated right-of-ways]; or

Sidewalk alternatives also apply to sit/lie, on page 9, Section 9-4-14(3)(2)

#### 4. Distance from shelters

Category 2: After Signage (Ordinance Section (D)(1), (2) and (4), page 5)

- (1) Within approximately one-quarter mile [ALTERNATIVE one-half mile], [ALTERNATIVE with boundaries set by the City Manager], of a homeless shelter located outside of the area in 9-4-14(3)(A).
- (2) Within [ALTERNATIVE approximately] three blocks of a homeless shelter [ALTERNATIVE with boundaries set by the City Manager] located inside the area in 9-4-14(3)(A)
- (4) At the time that the shelter becomes operational, within the area bordered by the western boundary of Manchaca Road, the eastern boundary of South 1<sup>st</sup> Street, the northern boundary of Lightsey Road, and the southern boundaries of Redd Street and West St. Elmo (South Austin Housing Center);[ALTERNATIVE delete (4)]

## Part 3. (A)(5) Installation of signs

(5) [ALTERNATIVE Unless needed pursuant to (A)(4), the city will only post city no-camping signs in the area bordered by the western boundary of Manchaca Road, the eastern boundary of South 1st Street, the northern boundary of Lightsey Road, and the southern boundaries of Redd Street and West St. Elmo at the time the shelter opens for operation.]

# 5. When to put up signage

# Part 3, page 7, (A)(2)

(2) The City has the resources to offer appropriate services and permanent housing to the individuals who are alleged to be in violation of the camping prohibition [ALTERNATIVE The City has offered appropriate services, including shelter or housing to the extent the Council has designated funding for such resources, based on this assessment];

### 6. How to treat Category 3, page 13

#### PART 6.

When the City Manager has determined that the housing wait list for people experiencing homelessness is 60 days or fewer, then the Manager shall bring back for Council consideration additional prohibitions or restrictions on camping, sitting, and lying that Council may consider and that may:

- a. Increase the distance from shelters where these activities are prohibited;
- b. Prohibit these activities on high pedestrian trafficked streets;
- c. Prohibit these activities along creeks and rivers or in floodways
- d. Prohibit these activities on more sidewalks.

### [ALTERNATIVE PART 6.

When the City Manager has determined that the housing wait list for people experiencing homelessness is 60 days or fewer, then the following is prohibited:

- (1) Camping on sidewalks (9-4-11(3)(B))
- (2) Sitting and lying (9-4-14(3)(B)) or camping (9-4-11(3)(B)) on all high pedestrian and vehicular traffic streets
- (3) Camping in all high-risk fire areas(9-4-11(3)(B))]
