## WILL OF EULALIO EDUARDO RENDON

I, EULALIO EDUARDO RENDON a resident of Austin in Travis County, Texas, publish and declare this to be my Will; and by executing this Will, I revoke all wills and codicils I have made previously.

## ARTICLE 1 IDENTIFICATION OF BENEFICIARIES

I am an unmarried man, having survived my spouse and I have children now living or deceased, either natural born or adopted. As used in this Will, the term "issue" means all of the lineal blood descendants of the person or persons designated in this Will, and includes any legally adopted children of such person or persons.

# ARTICLE 2 PAYMENT FOR DISPOSITION OF REMAINS

### Description of Expenses and Debts

- 2.01. I authorize my Executor to pay:
  - (a) All costs related to burial or cremation, e.g., all costs of a funeral and/or memorial service; the expenses of interment of my remains, including the costs of a gravesite, if necessary; the installation and inscription of a suitable marker at, and perpetual care of, the gravesite.
  - (b) All of my debts that are allowed as claims against my estate.

#### Source and Time of Payment

2.02. The payments authorized in Paragraph 2.02 are to be made from the property that comprises my probated estate that is not specifically devised under Article 4 of this Will, and shall be made as soon after my death as possible. The payment of all other debts, obligations, and costs of administration of my estate is to be made within the sole and absolute discretion of my Executor.
