

**ORDINANCE NO. 20190919-007**

**AN ORDINANCE ACCEPTING GRANT FUNDS FROM THE TEXAS DEPARTMENT OF PUBLIC SAFETY AND AMENDING THE FISCAL YEAR 2018-2019 OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE NO. 20180911-001) TO APPROPRIATE THESE FUNDS FOR REPAIRS TO CITY FACILITIES AND REPLACEMENT OF CITY PROPERTY DAMAGED OR DESTROYED BY THE FLOODING OF OCTOBER 2015, AUGUST OF 2017, AND OCTOBER OF 2018; AND AMENDING THE FISCAL YEAR 2018-2019 CAPITAL BUDGET (ORDINANCE 20180911-001) TO TRANSFER IN AND APPROPRIATE GRANT FUNDS FOR REPAIRS TO CITY FACILITIES AND REPLACEMENT OF CITY PROPERTY DAMAGED OR DESTROYED BY THE FLOODING OF OCTOBER 2015, AUGUST OF 2017, AND OCTOBER OF 2018.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** Council accepts grant funds from the Texas Department of Public Safety in the amount of \$1,314,087 for repairs to City facilities and replacement of City property damaged or destroyed by the flooding of May and October 2015, August of 2017, and October of 2018.

**PART 2.** Council amends the Fiscal Year 2018-2019 Operating Budget Special Revenue Fund (Ordinance No. 20180911-001) to appropriate \$1,314,087 for the following departments: Austin Energy \$6,681, Austin Fire Department \$153,673, Austin Police Department \$320,841, Austin Water \$17,073, Emergency Medical Services \$16,024, Homeland Security and Emergency Management \$24,628, Parks and Recreation Department \$2,027, the Public Works Department \$773,140, for repairs to City facilities and replacement of City property damaged or destroyed by the flooding of October 2015, August of 2017, and October of 2018.


**PART 3.** Council amends the Fiscal Year 2018-2019 Capital Budget (Ordinance No. 20180911-001) to transfer in and appropriate \$773,140 from the Operating Budget Special Revenue Fund for the Public Works Department's Falwell Lane project.

**PART 4.** This ordinance takes effect on September 30, 2019.
