Authorize negotiation and execution of four multi-term contracts for electrical repairs and related services with Alterman, Inc.; Elk Electric, Inc.; Facility Solutions Group, Inc. D/B/A FSG Facility Solutions Group, Inc.; and J.S. Electric, Inc. (MBE); each for up to five years for total contract amounts not to exceed \$10,885,000 divided among the contractors. Austin Water's requested authorization is \$1,980,000.

AMOUNT AND SOURCE OF FUNDING

Funding in the amount of \$143,000 is available in the Fiscal Year 2019-2020 Operating Budgets of Austin Water. Funding for the remaining contract term is contingent upon available funding in future budgets.

Purchasing Language:	The Purchasing Office issued a Request for Proposals (RFP) 8200 PAT3000REBID for these services. The solicitation issued on April 15, 2019 and it closed on May 7, 2019. Of the seven offers received, the recommended contractors submitted the best evaluated responsive offers. MBE/WBE:	(Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established.

These contracts will provide a continuous and reliable source for electrical services on an asneeded basis, for various City facilities. The electrical services will include commercial and industrial electrical installation, repairs, troubleshooting, and other related electrical services at over 300 City-owned facilities.

These contracts will replace an existing contract, which will expire on November 22, 2019. The requested authorization amounts for these contracts were determined using departmental estimates and historical spend.

An evaluation team with expertise in this area evaluated the offers and recommended these four contractors to provide these services based on applicable experience, technical program and proposed solution, pricing, local business preference and service-disabled veteran business enterprise.

PRICE ANALYSIS

- a) Solicitations: 272 notices were sent, including 11 MBE and 4 WBE firms with 2 M/WBE firms responding.
- b) Cost Analysis: The proposed contract represents a 6.5% decrease. The Index supports a 42% increase.
