Public notice was given for this solicitation CLMC733, Southland Oaks Wastewater Improvements), through the City's Vendor Connection web portal. Six bids were received and opened on August 8, 2019. Of the six bids received, five bids were from MBE/WBE certified firms. Facilities Rehabilitation, Inc. submitted the lowest responsive bid of six bids, including an allowance totaling \$20,000:
