Public notice was given for this solicitation (CLMA031 Existing Terminal Centralized BHS Upgrades), through the City's Vendor Connection web portal. Three firms submitted qualifications statements and submittals were opened on August 29, 2019. Of the three submittals received none of the firms submitting were certified MBE/WBE/DBE. Of the three firms evaluated, Whiting-Turner Contracting Company was determined to be the best value of the three proposals received:
