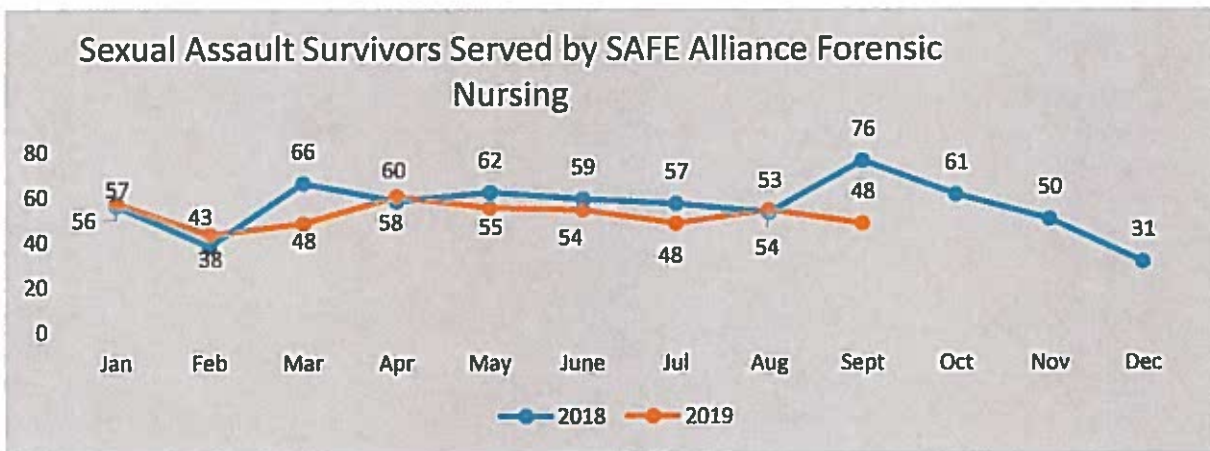

“In Custody” could mean:

- Outcry of sexual assault while in custody (by inmates, facility staff, or arresting officer)
- Arrested, made outcry about an assault that occurred prior to the arrest
- Outcry of sexual assault and taken into custody on scene when reporting

Texas Code of Criminal Procedure, Article 56.06 (a-1)

If a sexual assault is reported to a law enforcement agency within 120 hours of the assault, the law enforcement agency, with the consent of the victim, a person authorized to act on behalf of the victim, or an employee of the Department of Family and Protective Services, shall request a forensic medical examination of the victim of the alleged assault for use in the investigation or prosecution of the offense.

A law enforcement agency may decline to request a forensic medical examination under this subsection only if the person reporting the sexual assault has made one or more false reports of sexual assault to any law enforcement agency and if there is no other evidence to corroborate the current allegations of sexual assault.
