

# URBAN RENEWAL BOARD APPROVED MINUTES

REGULAR MEETING September 16, 2019

The Urban Renewal Board convened the regular meeting on Monday, September 16, 2019, at the Street-Jones Building, 1000 East 11<sup>th</sup> Street, Room 400A, Austin TX.

Chair Ellis called the Board Meeting to order at 6:07 p.m.

An Urban Renewal Plan's primary purpose is to eliminate slum and blighting influence within a designated area of the city.

Agency of the City of Austin (Agency) on any issue. The Agency may not debate any non-agenda issue, nor may any action be taken on any non-agenda issue at this time however the Agency may present any factual response to items brought up by citizens. (Attorney General Opinion – JC-0169) (Limit of three minutes each).

Discussion and possible action authorizing the negotiation and execution of a 30-day amendment extending the expiration date to October 31, 2019, to the License Agreement with Diverse Arts Culture Works for the properties located at 1106, 1112 and 1114 East 11<sup>th</sup> Street and 1109 Juniper Street.

Conservation Combining District (NCCD) to parallel the structure of the current East 12<sup>th</sup> Street NCCD.

Staff provided overview of backup materials. Board to provide comments to staff by October 7<sup>th</sup>. No action was taken.
