ORDINANCE NO. 20191017-025 AN ORDINANCE AMENDING CITY CODE SECTION 2-1-102 RELATING TO THE AN-IMAL ADVISORY COMMISSION; AND AMENDING CERTAIN SECTIONS OF CITY CODE CHAPTER 3-1 (GENERAL PROVI-SIONS): ADDING CONFORMING DEFINI-TIONS TO SECTION 3-1-1; AMENDING SECTION 3-1-21 TO MANDATE CORE IMMUNIZATIONS UPON INTAKE AT IM-POUND FACILITIES; AMENDING SEC-TION 3-1-23 RELATING TO FEE WAIV-ERS; MAKING CONFORMING CHANGES TO SECTION 3-1-25 RELATING TO DIS-POSITION OF AN IMPOUNDED ANIMAL; ADDING SECTION 3-1-26 REQUIRING NOTICE TO RESCUE ORGANIZATIONS; AMENDING SECTION 3-1-27 REVISING ANIMAL SHELTER REPORT CONTENT; AND AMENDING 3-1-29 MANDATING ANIMAL STERILIZATION.
