

M/WBE Summary

Participation goals stated in the solicitation were 1.90% African American; 9.00% Hispanic; 4.90% Native Asian; and 15.80% WBE. The recommended firm provided a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department. The alternate firm provided a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Public notice was given for this solicitation CLMP281 -Architectural Services for EMS Facility Renovations, through the City's Vendor Connection web portal. Six firms submitted qualifications statements and submittals were opened on September 11, 2019. Of the seven submittals received four submittals were from MBE/WBE certified firms. Of the seven firms evaluated, MWM DesignGroup, Inc. was determined to be the most qualified:
