

M/WBE Summary

Participation goals stated in the solicitation were 1.61% African American; 2.64% Hispanic; 2.54% Native Asian; and 4.72% WBE. The recommended firm provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department. The alternate firm provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Public notice was given for this solicitation CLMA029 – Fire and EMS Stations Rebuild and Renovations, through the City's Vendor Connection web portal. Six firms submitted qualifications statements and submittals were opened on August 15, 2019. Of the six submittals received one submittal was from MBE/WBE certified firms. Of the six submittals received one was found non-responsive, and Flintco, LLC was determined to be the best value of the five firms evaluated:
