35 (B) This Article shall apply to all new construction and major renovations containing  
36 the use of all or a portion of a building or structure, as described in Subsection (A).  
37

38 **§ 4-16-22 DIAPER CHANGING STATION REQUIRED**

- 39 (A) Except as provided in Subsection (C), each floor of a structure with one or more  
40 public restrooms must include the number of compliant diaper changing stations  
41 described below:  
42  
43 (1) if the diaper changing station is installed within a gender neutral restroom,  
44 the maximum number of diaper changing stations required on each floor is  
45 one; or  
46  
47 (2) if the diaper changing station is installed within a gender specific restroom, a  
48 diaper changing station is required in each gender specific public restroom  
49 with a total maximum number of two diaper changing stations per floor.  
50  
51 (B) A diaper changing station is compliant if it complies with federal, state, and local  
52 accessibility and safety standards.  
53  
54 (C) The building official may modify or waive the requirements in Subsection (A) if  
55 the building official determines that the:  
56  
57 (1) spatial or structural limitations of the public restroom will not accommodate  
58 a compliant diaper changing station; or  
59  
60 (2) installation of a compliant diaper changing station will make the public  
61 restroom noncompliant with federal, state, or local accessibility and safety  
62 requirements.  
63

64 **§ 4-16-23 SIGNAGE REQUIRED**

- 65 (A) A person with control over a structure subject to this article must install and  
66 maintain compliant signage that indicates the public restroom includes a diaper  
67 changing station.  
68  
69 (B) A diaper changing station sign is compliant if it complies with federal, state, and  
70 local accessibility standards.

74       **§ 4-16-24 OFFENSE AND PENALTY**

75       (A)   A person who violates or fails to comply with a requirement of this article commits  
76           an offense.

77       (B)   An offense under this article is a Class C misdemeanor offense, punishable in  
78           accordance with Section 1-1-99 (*Offenses; General Penalty*).
