


Rebates and Incentives Budget, FY20 YTD


Water Waste Enforcement Activity FY20 YTD Assessed Violations Residential Commercial Multi-Family





Public Outreach Activity Number of Events




Public Outreach Activity Populations Reached













Cumulative Total Peak Water Savings, Gallons Per Day (GPD)

Total Cumulative Water Savings Projected for FY 2019




WATER USE - GALLONS PER CAPITA PER DAY (GPCD)





Daily Water Usage October 2019




