#### **Minutes:**

## 1. Call to Order

Mary Arnold called the meeting to order at 9:30 a.m.

## 2. Item 1 (Citizen Communication)

- a. <u>Dawn Lewis (City of Austin Parks and Recreation Board)</u>: Ms. Lewis introduced herself as Councilmember Alter's appointee to the City of Austin Parks and Recreation Board and serves as the Chair. She stated that she was attending to observe the meeting.
- b. Richard Suttle (Representing the University of Texas): Mr. Suttle gave background on the University of Texas' (UT) attempts to "solve the Muny/Brackenridge Tract question." UT has signaled that it is willing to sell Muny to the City of Austin for a "reasonable value" rather than at market value. The reasonable value may be \$109,500,000, based upon a UT appraisal. The market value could range from the appraisal district's \$200,000,000 valuation up to a \$400,000,000 value based upon the recent HEB lease. Mr. Suttle believes UT would accept \$109,500,000 at this time. The City of Austin has been asked to consider multiple strategies, including land trades and tax increment financing (TIF). The idea of a "parks bank" that developers could pay fees into is another concept for raising funds to preserve Muny that

has been envisioned by Mr. Suttle. From his perspective, the 10-1 Austin City Council is simply not in favor of giving anything of significant value to UT in order to acquire ownership of Muny. After thoughtful consideration, UT rejected an "exclusive agreement" sought by the non-profit Muny Conservancy; which would like to meet the publicized "reasonable value" price from fundraising. Mr. Suttle noted short time remaining until the lease expires on May 20, 2020. UT polled West Austin and the city at large regarding Muny. The results showed that paying for a park was favored compared to paying for a golf course. It was alluded to that this poll may have played a role in Senator Watson's legislation that ultimately formed the Save Historic Muny District.

- c. Ross Pringle: Mr. Pringle stated that he has brought his son, Brantley Pringle, to witness a government meeting, as a required component of earning a Boy Scouts of America merit badge. Mr. Pringle supports the significance of the civil rights history associated with Muny.
- d. Brantley Pringle: Mr. Pringle is student at McCallum High School. In response to Mr. Suttle's pertinent question, Mr. Pringle answered that he was not aware that there was a time at Muny when African Americans were denied access based upon their race.
